Re: Auditing Services

The District issued a Request for Proposals (RFP) for audit services as part of its due diligence and commitment to best practices in governance. The RFP process helps ensure compliance with state and federal requirements, including Illinois State Board of Education (ISBE) reporting, while promoting transparency, accountability, and the receipt of high-quality services at a fair and reasonable cost.

Proposals were evaluated using established criteria, including experience with Illinois school districts, qualifications of assigned personnel, audit approach, cost, references, and staff support requirements. Two proposals were received - from Lauterbach & Amen, LLP and Bohnsack & Frommelt, LLP. Each proposal was independently scored by committee members using an evaluation rubric. Scores were compiled, and the committee discussed the relative strengths and considerations of each firm to support an objective comparison.

Based on the evaluation results, and average score, the committee recommends awarding the audit services contract to Lauterbach & Amen, LLP for a three-year term, with the option to extend for up to two additional years upon mutual agreement. Lauterbach & Amen demonstrated strong experience with Illinois public schools, comprehensive knowledge of ISBE requirements, highly qualified staff, a clear audit methodology, reasonable pricing, and positive references.
