### Claims of Accountability System (p.14 ESSA plan)

The purpose of the Arkansas Educational Support and Accountability System is to ensure all children have access to opportunities for a high quality education and to make progress in closing long-standing achievement gaps. The system is intended to achieve the following expectations.

1. To identify underperforming schools and subgroups of students within schools and notify LEA leaders when schools within their systems are most in need of the LEA's support to achieve immediate and sustained improvement.

2. To provide support that will empower LEAs to uncover the needs of their underperforming schools and/or student subgroups and enable LEAs to implement evidence-based strategies to address those needs.

3. To inform educators and stakeholders about school quality and student success as well as the progress and outcomes of schools' and districts' continuous improvement efforts.

## Criteria for Accountability 2021

**Valid** - calculated in compliance with approved ESSA plan (business rules)-ESSA School Index 2021 measures what it is was validated to measure.

**Reliable** - the quality of being trustworthy or of performing consistently well, (a reliable source of information)

• 95% tested

**Comparable** - of equivalent quality; capable of or suitable for comparison

- loss of learning
- lack of student engagement in learning
- student instructional options



### 1. Options for Academic Achievement Indicator

Claim: The performance indicator provides accurate information about the degree to which schools support students in meeting grade level academic standards.

Student level:

- Calculate missing 2020 score by imputing--use 2019+2021 score/2 for students' 2020 score.
- Or do not impute the score at all and just use the students' 2021 score as it is.

School level must meet valid, reliable, and comparable standard

- use 2021 achievement data or
- use 2-year (average 2019 and 2021 school scores /2) for 2021 or
- use 3-year--imputing 2020 or
- Or use best of 1, 2, or 3 year achievement scores for weighted achievement

### 2. Options for Growth Indicator

Claim: The growth indicator provides accurate information about the degree to which schools support students in meeting the expected growth in achievement. Student Level:

- calculate student growth with missing 2020 year--the modeling provided adequate results for this to be used.
- calculate student growth imputing a 2020 proxy score (2019+2021/2) inserted as 2020 score and compute the student growth

School Level: must meet valid, reliable, and comparable standard

- use 2021 growth
  - missing a year of data (2020)
  - use the mean growth scores from first option above
  - use mean growth scores from 2nd option
- use 2 year school level average (2019 + 2021/2)
- use better of current year or 2 year mean school growth score
- use better of 2021 growth or 2019 growth score.

### 3. Graduation Rate

Claim: The graduation rate indicator provides accurate information about the degree to which schools graduate students in the cohort.

Arkansas will have 2020 data available for graduation rate indicator

Recommendation: no change for ESSA School Index calculation



Claim: The School Quality and Student Success indicator provides accurate information about the degree in which schools support participation in and opportunity for learning.

2021--Arkansas will have all components of SQSS

School level:

• Use 2021 current year data only
