The GE Diamond II Access Control System hardware will no longer be supported this year. Therefore, we are required to engage in the bidding process for an updated replacement.

Bids were publicly posted on Thursday, April 5, 2018 in the Kane County Chronicle. On Thursday, April 19, 2018 at 3:00 pm, bids were opened and read aloud for the district-wide Access Control System replacement.

Nine (9) contractors were invited to bid. Four (4) contractors responded. The results are shown below. The low bidder is highlighted.

The contractors submitting bids were:

Johnson Controls – Milwaukee, WI Siemens Industry Inc. – Mt. Prospect, IL Pentegra Systems – Addison, IL Esscoe, LLC – Lake Zurich, IL

At your direction, CS2 Design Group (CS2) prepared a full set of access control system upgrade documents and placed them out for bids on Thursday, April 5, 2018. A total of nine access control system contractors attended the pre-bid conference with four bids submitted and received by Geneva Consolidated Unit School District 304 on Thursday, April 19, 2018.

The apparent qualified low bidder for the Access Control System RFP Base Bid was Esscoe, LLC with a base bid of \$201,000.00 for Genetec, Synergis Enterprise Access Control System. The base bid includes a \$40,000.00 contingency allowance.

The Bid also included an Alternate Bid in the amount of \$201,000.00 for work to add a Lenel, OnGuard Access Control System, this Alternate Bid also includes a \$40,000.00 contingency allowance.

CS2 has reviewed the project scope and submitted bid amounts with Mr. Mike Cook, Principal at Esscoe, LLC and he has stated that they are comfortable with their bid submission. A letter of Esscoe's confirmation is attached. CS2 also has experience working with and finds no reason not to award to them as the lowest responsible bidder.

There was a low base bid amount of \$178,615.00 submitted by Pentegra Systems which was disqualified for not conforming to the specifications including the pre-bid conference discussions and addendums.

On Thursday, April 26, 2018 the Base Bid and Alternate Bid access control system manufacturer representatives met with Geneva CUSD 304 and CS2 Design Group to review each systems features and benefits. Based on the input from the school district, the access control manufactures presentations, the bids, and all the other information received and reviewed it is our recommendation that the Alternate Bid - Lenel, OnGuard Access Control System as submitted for a total contract sum of \$201,000.00 be awarded to Esscoe, LLC. The preceding recommendation represents our interpretation and understanding of the bids submitted.
