(HB3 Required Goal) Goal 3*: The percentage of graduates that meet the criteria for CCMR will increase from 72% to 88% by August 2024 and increase to 95% by 2028. (HB3 Required Goal) D. **Summary:** Corgan Architects has created a schematic design for the drives, parking, and playground improvements. The designs were created through a needs assessment, work with an engineering team to evaluate possible

cuing and playground configurations, and feedback from campus and district administration, new elementary design staff and teacher committee, and from the bond oversight/facilities planning committee.

Bond 2024 projects included drive and parking improvements and Bond 2021 funds are available to move, improve and make playgrounds accessible for all students. Moving playgrounds is part of improving the drives and parking and creating a safe play area.
