Presentations/ Recognitions CrossFit of North Texas has become an avid supporter of Denton ISD, its students and its staff over the past few years. The organization promotes physical fitness and healthy lifestyles thru its workout programs and counts several district families and staff as dedicated members. CrossFit of North Texas partnered with the Denton Public School Foundation to start the Barbell Bash fundraiser in 2013. To date the Barbell Bash – a competition of aerobic and strength-training exercises – has raised more than \$15,000 for atrisk students in Denton ISD. Included in that amount is a donation of more than \$8,300 for this year, presented by representatives of CrossFit North Texas and Amy Gulley, a dyslexia therapist for the district.

Drs. David and Karen Goff, with support from Cook Children's Health Care System, recently partnered with the Denton Public School Foundation to donate more than \$4,300 to the district's department of health services to supply funds for automatic external defibrillators or AEDs.

Discussion of Career & Technical Education Annual Report Carla Ruge, Director of Career & Technology and Marcus Bourland, ATC Principal provided the Board with an overview regarding Denton ISD Career and Technical Programs, including highlights, funding, and program performance. CTE enrollment continues to increase as total enrollment increases. Career & Technology has 30 different programs; 127 CTE

Courses; 15 Clusters; 40 Certifications and Licensing and 42 College Articulated Agreements.

Discussion of High School Dual Credit Program Vicky Christenson, Director of Secondary Academics provided the Board with information on the District's high school dual credit program which helps our students to earn both high school credit and college credit at the same time. Current dual credit agreements with TWU, UNT and NCTC allows the district to offer 15 dual credit courses on our high school campuses. All dual credit courses, which are aligned with Advanced Placement courses, are taught on Denton ISD campuses by district teachers. This model maximizes student participation since students do not have to travel to the colleges, guarantees teaching of the TEKS, and creates a classroom atmosphere where students feel safe and supported as they engage in more rigorous learning.

Most importantly the end result of this survey provided evidence that our community sees our students as more than just numbers on standardized tests.

David Hicks, Area Superintendent for Secondary Academics informed the Board of Trustees of the information reported to the Texas Education Agency through PEIMS regarding disciplinary actions taken during the 2014-2015 school year. TEA requires reporting of every disciplinary action that removes a student from the regular classroom or educational placement for periods of one school day or more. Typically, this includes any action involving in-school suspension, out-of-school suspension, placement in a disciplinary alternative education program (DAEP), or expulsion from school (JJAEP). There are also requirements for reporting specific types of behavior for analysis by the Safe and Drug Free Schools Division of TEA, which administers state and federal grant money.
