I. SUPERINTENDENT'S REPORT

A. VCSF Annual Report - Warren Lawrence

Warren gave a brief update on the VCSF accomplishments for 2009-10.

B. Recognition of Ray Shearer - Unsung Hero

Ray has worked for the district for several years and provides a high level of service to our students every day. HS is down a bit. He stated it is very early and the numbers will change. We will keep the Board posted as new numbers come in.

Preservice was at Portage Northern High School. Supt. Glaes stated that Mike Schmoker, the speaker, is nationally recognized and gave a great address regarding changing school achievement and how we can do more or do it differently.
