RE: Kindergarten Program Review Committee Update

Enclosed please find the agendas for the September 27, 2022 and October 27, 2022 Kindergarten Review Program Committee meetings. After the initial September meeting, Working Groups were formed to investigate the potential implications a full-day Kindergarten program could have on District 90 finances, facilitates, and student growth and achievement. Working Groups will also review geodemographic data, develop a survey to garner community feedback, and a communications plan to highlight committee progress. Each working group also meets monthly in between the full committee meeting times. The full committee will continue to meet monthly through December.

At the December 6, 2022 Committee of the Whole meeting, the Board of Education will receive an update on committee progress, and engage the community in discussion related to the work of the Kindergarten Program Review Committee through a Townhall format.






