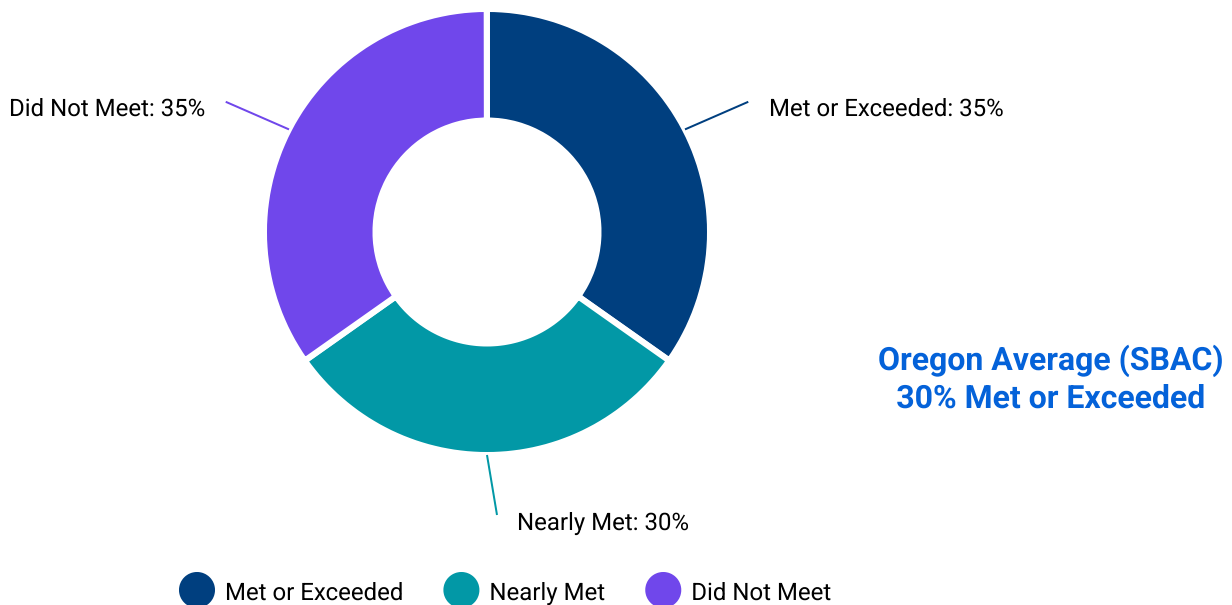

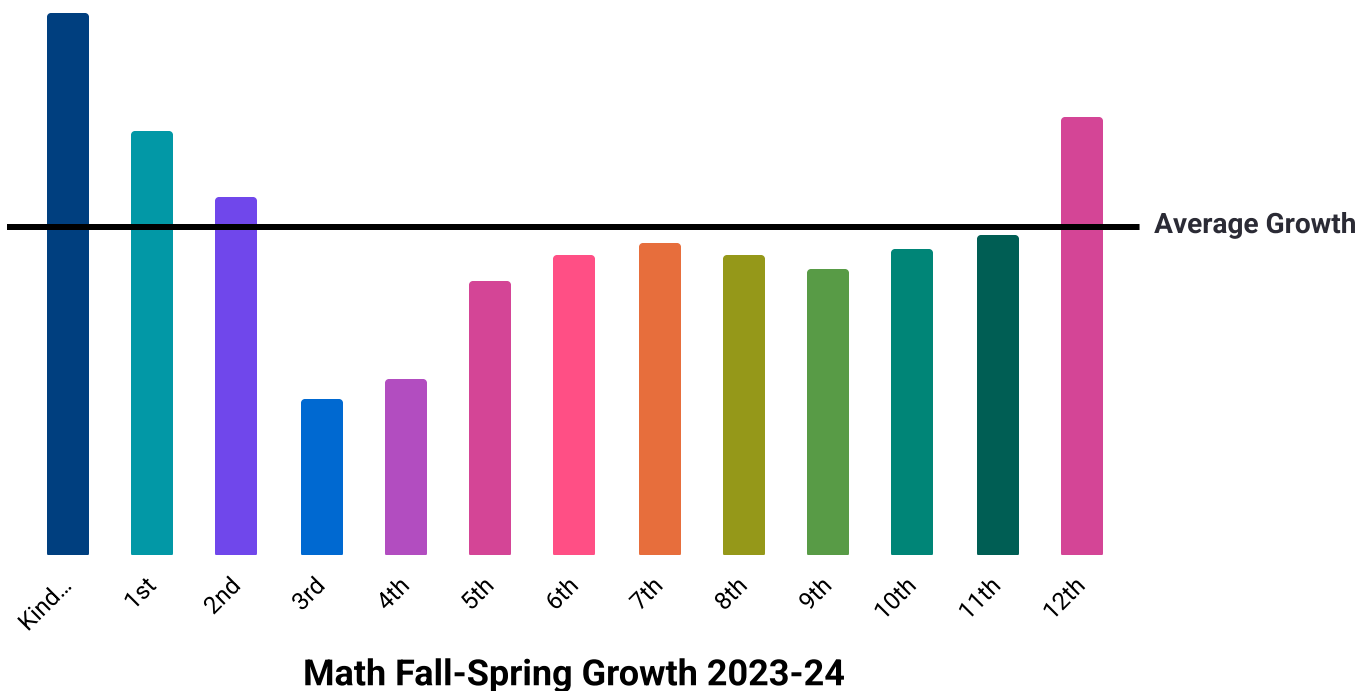
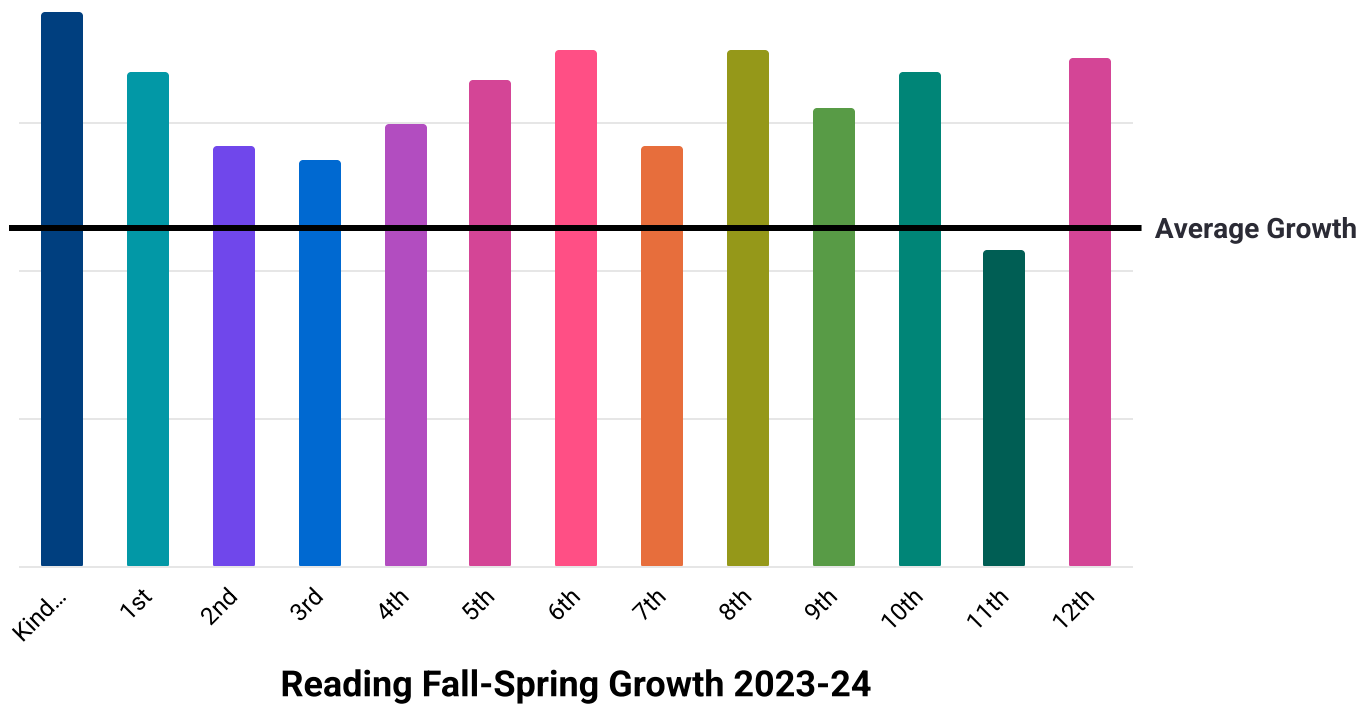
8th Grade Mathematics

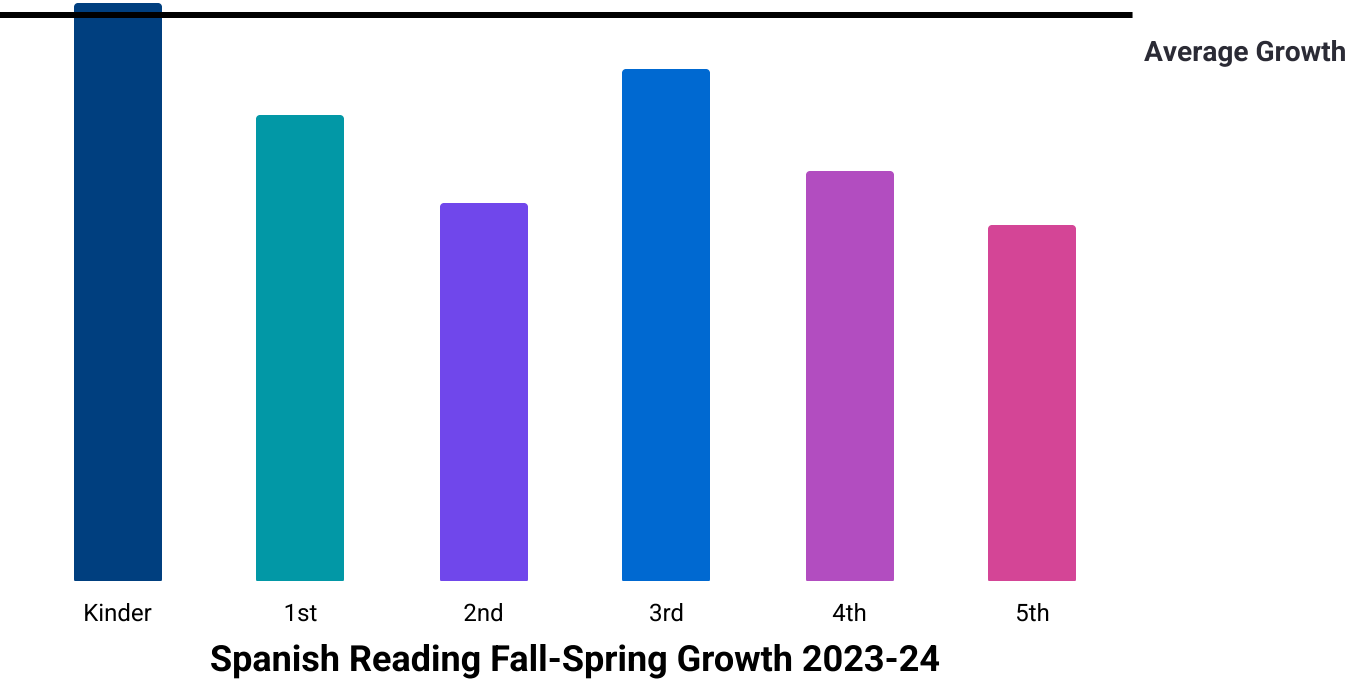
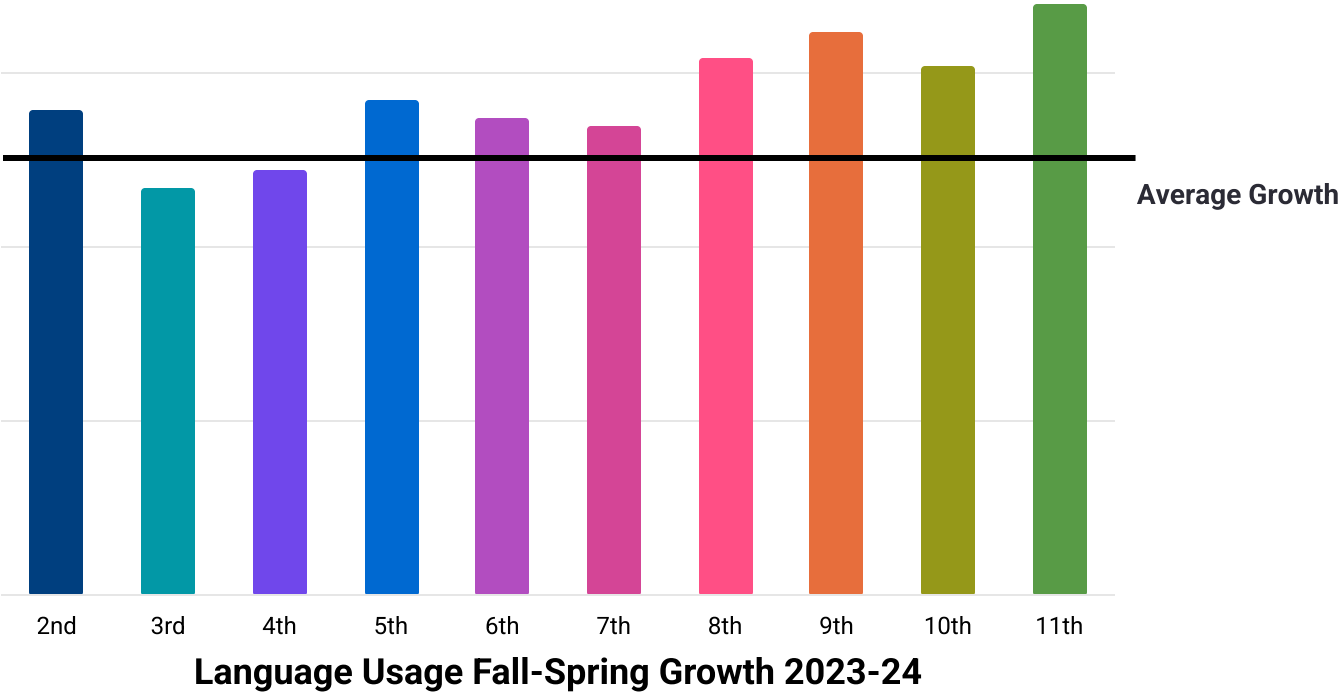

The nutrition program is active in Farm to School offerings and provides scratch cooking for many meals.

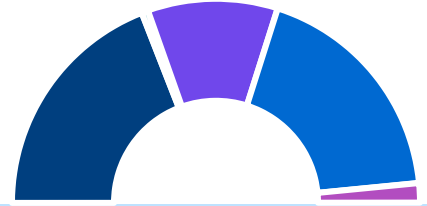
Dual Credit

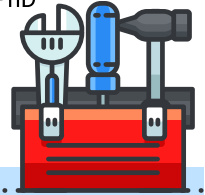

Facilities

Voters approved a \$45.2 million bond in November of 2022. The district secured \$4 million in matching funds, then sold the bonds at a premium for additional \$2 million in facility funds at no cost to taxpayers. A new CTE building at UHS and Columbia Vista Intermediate opened in fall of 2025.
