#### I. Open Hearing

A Public Hearing was held Wednesday, January 20, 2010, in the Student Activity Complex, Fine Arts Building, 5208 Santa Claudia Lane, Laredo TX 78043. An announcement was made by the Board President calling the meeting of the United Independent School District to order at 4:30 p.m. The record showed that a quorum of Board members was present, that the meeting had been duly called, and that notice of the meeting had been posted in accordance with the Texas Open Meeting Act, Texas Government Code Chapter 551.

# II. Texas Education Code §39.053 Presentation of Annual Report Describing the District's Educational Performance on the AEIS (Academic Excellence Indicators Systems) Indicators

As required by Texas Education Code §39.053, District administrators presented the 2008-09 Academic Excellence Indicator System (AEIS) report for United Independent School District.

Dr. Guadalupe Gorordo, Executive Director of Instructional Accountability, presented an overview of the District's AEIS report. The first section covered in the presentation was an overview of the comprehensive reporting system which is defined by statute was presented by Dr. Guadalupe Gorordo, Executive Director of Instructional Accountability. Districts have published the report annually since 1990-91, and it gives parents and community a snapshot of 1) District performance (Section I of the AEIS Report), and 2) a District profile (Section I of AEIS report). The data used to determine District and campus accountability ratings is collected through the state data reporting system (PEIMS) and the student assessment system.

The District was rated as Academically Acceptable for 2009 and received Gold Performance acknowledgements for its Recommended High School Program – class of 2008.

In viewing the District/Campus performance in Section I, the data for all indicators used to determine accountability ratings include 1) Spring 2009 TAKS performance, 2) Completion rate 1 for class of 2009, and 3) the 2008-09 annual dropout rate for grades 7 and 8. In the future, additional data that will be considered will be 1) an accountability preview for 2011, 2) the number of college-ready graduates, and 3) English Language Learner (ELL) progress measure.

Accountability standards for the years 2007-2011 were presented to the Board showing how the standards have increased in select areas each year.

The annual drop out rate for grades 7-8 and the high school completion rates grades 9-12 were then shown.

In summarizing the accountability ratings, UISD had the following ratings:

The presentation continued outlining the sum of all grades tested an those that met TAKS standards, as well as, the District's percentage for TAKS Commended Performance, 2008 and 2009 TAKS participation. The District earned an 87% (Class of 2009) and 86% (Class of 2008) cumulative passing rate for the TAKS Exit Level. The percentages of success in the Student Success Initiative were highlighted.

A new measure was the English Language Learners (ELL) progress measure.

Data complied by Instructional Accountability noted that the completion rate for the class of 2008 Indicated 89.9% graduated, 8.2% received their GED, 1.7 continued with high school, and 0.2% dropped out after four years.

The presentation also include the college readiness indicators and future accountability indicators including high school graduates who:

- Met the Higher Education Readiness Component) HERC standard on Exit Level ELA/Math; or
- Scored more than or equal to 500 on SAT Reading/Math and higher or equal to

1070 total; or

 Scored higher than or equal to 19 on ACT English/Math and greater than or Equal to a 23 composite score.

Mr. Eduardo Zuniga, Associate Superintendent for Support Services, addressed the Board regarding violent and criminal incidents whose reporting was required by Texas Statute 39.053. The speaker indicated there was a total number of 118 incidents on UISD campuses at a 30% rate for an enrollment of 39,411 students. The data from PEIMS reporting included the following:

Mr. Zuniga sated that the District has managed to keep violence, alcohol, and tobacco use at a limited use level through its comprehensive district wide Safe and Drug Free Schools Plan.

Mr. David Garcia, Assistant Superintendent for Human Resources, presented the District Profile with demographic data about students and staff. Of the 39,935 students reported, the information was provided for students by grade from Early Childhood Education through Grade 12. The speaker also outlined the ethnic distribution of students and those identified as economically disadvantaged, Limited English Proficient (LEP), students with disciplinary placements and at risk students. In addition, demographic information was provided for students identified as special education.

Mr. Garcia reviewed information on teaching staff by ethnicity and sex, by highest degree held, and teachers by the number of years of experience. He also presented salary information and turnover rate for teaching staff.

Ms. Laida Benavides, Assistant Superintendent for Business and Finance, presented tax information, annual revenues, expenditures and program information.

A new section in the report dealt with 2008-09 district performance for current year LEP students.

Administrators concluded the presentation to the Board by advising where the report is available for viewing which includes:
