Recommendations:

Administration will present proposed boundary changes for the school year 2018-2019 for San Isidro Elementary.

-----SAN ISIDRO ELEMENTARY-----

- For School Year 2018-2019, creating a new boundary for San Isidro Elementary School's northwestern boundary begins at IH35 and the northern UISD boundary line. South along IH35 to include areas both east and west of IH35 to Bob Bullock Loop 20-US Hwy 59. Eastward and southward along Bob Bullock Loop 20-US Hwy 59 to Casa Blanca Lake Rd. East to UISD boundary line. Subdivisions include: San Isidro North East area, Lakeside, and The Loop Subdivision.

-----COL. S. BENAVIDES ELEMENTARY-----

- For School Year 2018-2019, creating a new boundary for Col. S. Benavides Elementary School's northeastern boundary begins south of Conde Dr. and Bob Bullock Loop 20-US Hwy 59. South on Bob Bullock Loop 20-US Hwy 59 to Jacaman Rd. West on Jacaman Rd to area east of Summerwind Subdivision. North along Green Meadow Ct to E Del Mar Blvd. East on Del Mar Blvd. to Country Club Dr. North along Country Club Dr, Azinger Dr, and Crenshaw Dr. to Palmer Dr. East along Palmer Dr, Jones Dr, and Winridge Dr. North on Winridge Dr. along Plantation East Dr. to area south of Conde Dr. East along Conde Dr. to Point of Beginning.

-----BORCHERS ELEMENTARY-----

- For School Year 2018-2019, creating a new boundary for Borchers Elementary School's northeastern boundary begins at Havana Dr. and Bob Bullock Loop - US Hwy 59. South on Bob Bullock Loop-US 59 to area south of Conde Dr. West along Conde Dr to Plantation East Dr. South on Plantation East Dr to Winridge Dr. West on along Winridge Dr. to area south of Jones Dr. to Country Club Blvd. North along Country Club Blvd, Orange Blossom Lp, and International Blvd. to Stonefield Ln. East on Stonefield Ln. to Casimir Dr. North on Casimir Dr. to Havana Dr. East on Havana Dr. to Point of Beginning.

-----MALAKOFF ELEMENTARY-----

- For School Year 2018-2019, creating the new boundary for Malakoff Elementary School's southwest boundary begins at IH 35 and Shiloh Rd. East on Shiloh Rd. to McPherson Rd. (only area north of Shiloh Rd. is included). North on McPherson Rd. to Monaco Blvd. East along Monaco Blvd. to International Blvd. North on International Blvd. to Lima Lp. East along Lima Lp. to Calle Vistoso. North along Calle Vistoso to Havana Dr. East on Havana Dr. to Bob Bullock Loop-US Hwy 59. North-west along Bob Bullock Loop 20-US Hwy 59 to IH35. South along IH35 to Point of Beginning.

-----M. DE LLANO ELEMENTARY-----

For School Year 2018-2019, creating the new boundary for M. De Llano Elementary School's northwestern boundary begins at IH35 and Shiloh Rd. East on Shiloh Rd to McPherson Rd. (includes areas north and south of Shiloh Dr, but excluding the Monaco Apartments). North on McPherson Rd. to Longhorn Dr. East on Longhorn Dr. to Jennifer Lp. South along Jennifer Lp, Chris Ln, and Country Club Dr. Southwest along Country Club Dr. and Palmer Dr. to Stillmeadow Ct. South along Country Club Dr. to E Del Mar Blvd. (encompassing areas east and west of Country Club Dr). West on Del Mar Blvd. to McPherson Ave. North along McPherson Ave to area south of Puig Dr. West along Puig Dr, Siller Lp, and Shiloh Rd. to Point of Beginning.

Rationale:

The propose boundary changes would clarify the school boundaries due to land development, and historical student attendance.
