

**RESOLUTION OF THE BOARD OF TRUSTEES
OF THE FRISCO INDEPENDENT SCHOOL
DISTRICT APPROVING THE INITIATION OF
THE DISTRICT OF INNOVATION PLAN
RENEWAL PROCESS FOR ANTICIPATED
RENEWAL OF THE FRISCO INDEPENDENT
SCHOOL DISTRICT'S DISTRICT OF
INNOVATION PLAN FOR 2027**

WHEREAS, Frisco Independent School District ("Frisco ISD" or the "District") is committed to providing high-quality education to students within its community and seeks to maintain local control over certain educational programming and operations to best meet the particular needs of the Frisco ISD community;

WHEREAS, the Texas Education Code Chapter 12A allows a public school district to be designated as a District of Innovation (DOI) if the public school district showed acceptable performance on their most recent performance rating under the Texas Education Code Section 39.054;

WHEREAS, Frisco ISD not only had acceptable performance based on its most recent state rating but, in fact, received an "A" rating, indicating exemplary performance;

WHEREAS, a DOI has the opportunity to specify exemptions to state-level legal requirements in favor of alternate local practices in the interest of local control, flexibility, and educational innovation;

WHEREAS, Frisco ISD has been a DOI since 2017 with the adoption of its DOI Plan and then renewed its DOI Plan five years later in 2022;

WHEREAS, the District's current DOI, as amended, will expire in 2027;

WHEREAS, the Board of Trustees of Frisco ISD (the "Board") finds that it is in the best interest of the District to explore renewal and possible amendment to its DOI Plan prior to its current DOI Plan expiration in 2027;

WHEREAS, the Texas Education Code Section 12A.007 requires a formal resolution of the Board to initiate the process of DOI renewal and to specify the make-up of a DOI Committee for the DOI renewal process;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE BOARD OF TRUSTEES OF THE FRISCO INDEPENDENT SCHOOL DISTRICT THAT:

- 1) The above and foregoing recitals are true and correct and are incorporated into the body of this Resolution.

- 2) The Board authorizes the initiation of the DOI renewal process in accordance with the requirements set forth in Texas Education Code Chapter 12A.
- 3) The Board authorizes District Administration to select an appropriately sized DOI Committee from the membership of the Board-approved District Advisory Committee (DAC) and for such DOI Committee to include representation from District students, parents, staff, and community members in accordance with the requirements for representation of stakeholder groups outlined in the Texas Education Code.
- 4) The DOI Committee will be tasked with exploring renewal and possible amendment to the Frisco ISD DOI Plan and for presenting a draft DOI Plan for review by the public and the Board through public posting and for Board vote prior to the expiration of the District's current DOI Plan.
- 5) It is officially found and determined that the meeting at which this Resolution was considered was open to the public and public notice of the time, place and purposes of the meeting was given and posted as required by Chapter 551 of the Texas Government Code, as amended.
