

Attendance Boundary Adjustments Union Park Elementary Rezoning Plan

December 11, 2018

SUMMARY:

-This item requests the approval of Proposal One (East Creekside Area to attend Paloma Creek) of the Union Park Elementary Rezoning Plan. This includes the proposed adjustment of Bell Elementary and Paloma Creek Elementary boundaries. This will reduce overcrowding at Bell Elementary and provide the initial boundaries for Union Park Elementary.

PREVIOUS BOARD ACTION:

- Submitted as workshop item at Board Meeting on November 13, 2018.

BACKGROUND INFORMATION:

Community Forums were held on:

- October 16, 2018 at Paloma Creek Elementary
- October 18, 2018 at Bell Elementary

The Board of Trustees were provided an overview of two Union Park Zoning Proposals which include changes to Bell Elementary and Paloma Creek Elementary boundaries. Proposal One will rezone the East Creekside area (currently zoned for Bell) to attend Paloma Creek Elementary. Proposal Two will rezone the East Creekside area (currently zoned for Bell) to attend Union Park Elementary.

SIGNIFICANT ISSUES:

- This will reduce overcrowding at Bell Elementary and provide the initial boundaries for Union Park Elementary.

FISCAL IMPLICATIONS:

BENEFIT OF ACTION:

This proposal will promote more equity for students in the Braswell feeder pattern by..

- Providing more space for Bell Elementary
- Avoiding rezoning families multiple times
- Rezoning families that are farthest away from Bell Elementary
- Providing Bell Elementary student that are rezoned for Paloma Creek Elementary with transportation
