## BUFFALO-HANOVER-MONTROSE SCHOOLS ISD 877 DATA PRACTICES ACCESS PROCEDURES

Individuals seeking access to government data from the School District may make requests to the responsible authority or designee(s) listed below for each type of data. Public data may be accessed during regular business hours, 8:00 a.m. to 4:30 p.m., when the School District is open and in session, upon reasonable notice.

Depending upon the nature and volume of the data and staffing needs, the School District may not be able to retrieve the data immediately. Individuals seeking public data are not required to provide their name or a reason for accessing public data. However, if data is not immediately available for review, the District may ask for a name and telephone number to call in order to notify you when the data is available for review. If you would prefer not to provide this information, you may instead check back with the listed responsible authority or designee as to the status of the requested.

Individuals seeking private data regarding themselves or their children may be required to provide proof of identity and relationship to the student. Individuals seeking access to private data on other individuals shall be required to provide a written release from the individual subject of the data or other authorization establishing their right to access the data, such as a court order. Depending upon the nature and volume of the data and staffing, the School District may not be able to retrieve the data immediately.

Copy charge: If 100 or fewer pages of black and white, letter or legal size paper copies are requested, actual costs shall not be used, and instead, the charge shall be no more than 25 cents for each page copied.
