Mr. Ismael Mijares, Deputy Superintendent for Business and Finance, informed the Board that the same funding that has been for past years is still what is being used. Also, that the State has not given the district any additional funding or have we lost any funding. He started the presentation by explaining the four categories of funds/budgets as per TEA requirements. They are General Fund (20 fund budget). Special Revenue Funds (4 fund budgets), Debt Service Fund (1 fund budget) and Capital Project Fund (0 Fund Budget). The General Funds are State Mandated programs such as Food Service. Most of the money is in the General Fund (M&O) 97,49%. Special Revenue Fund is 59%. Debt Service Fund is 1.92% and Capital Projects are at 0%. Special Revenue Fund includes the Food Service Summer Program as required by law. It is a Federal Grant received, it is an entitlement, as the Visually Impaired Program received from the State under Special Education Program, the IMA (Instructional Materials Allotment), and the Campus Activity Fund. These are the Special Revenue Funds; these are funds designated by the State and how it is to be used. Mr. Mijares reviewed the budget groups as required by TEA (General Fund, Debt Services Fund, Special Revenues Fund, and Capital Projects Fund). All districts in Texas prepare their budgets in the same way. TEA requires all districts to post their budget on district website, excluding the Food Service Program as it is audited every year. Our major funding source of Revenue is the State -71.79%. Local Taxes - 15.85%. Federal - 8:82% Other Local - 3.54%. The District is one of the few in the state that pay 88% of the cost of Health insurance and the employees only pay 12%. Other budgetary matters discussed were Budget Assumptions, Proposed Budget Workshop Schedule, Additional Request and other budgetary issues. The 2024-2025 Estimated Ending Fund Balance for August 31, 2025 is \$56,552,287,00. Board Members questions and concerns were addressed.
