E. Update on Equity Center Lawsuit- the Texas Tribune has an excellent publication available regarding the now SIX lawsuits against the state. The article shows a chart of each lawsuit and what the focus of each suit will be. It was originally published in February when there were only FIVE lawsuits, so the sixth suit is not included in the charts. A majority of

districts in the state are involved in one of the six suits. Early indications are that the judge will be pushing to have a decision sometime during the upcoming legislative session.
