

# K-5 Assessment Days/ Family Connections

Discussed March 12 study session. This will be for 2021-22.

### What?

- All teachers will spend 30-45 minutes meeting with individual students to get to know them personally and their strengths and goals readers.
- They will get to know the student and make connections. They will complete a running record or grade level appropriate assessment to determine a student's instructional reading level, strengths as a reader, and goals for growth.
- Each student would get to book shop with free books from Scholastic Book Fair Points.
- Family connection day will be available with community and school supports in the lunchroom/gym. (PTO, bus, lunch, Community Ed, MAC, North Holmes, and other community resources)
- Families will have an opportunity to share information and goals for their child.

#### When?

### Option 1

Aug. 23, 24, 2021- dates prior workshop week and K-12 students start school the day after Labor Day on Sept. 7 and elementary gets done 2 days early on June 7.

### Option 2

Sept. 7-8, 2021

The first day of school will be Sept. 9, 2021

### How?

- Families will sign up for students to have an optional 30-45 minute meeting with the teacher similar to conference sign up.
- If families cannot come, there will be a shortened open house and the personal connections will happen the first 2 weeks of school in the classroom.
- New students may have additional assessments with reading, math, EL, SPED teachers.

- MAC and/ or Community Ed could provide 3 hour classes to support families who may need child care. Scholarships could be granted for families who cannot financially support them.
- PTO could run card sharks and/or strategy games
- Open house can be re-envisioned and staggered with WW and OHA.

## Why?

This will also build an individual connection with student, teacher, and family.

Currently teachers are meeting with each student for 30-45 minutes to complete a running record and determine students reading levels, strengths and goals before conferences in Nov. Students are currently instructed by substitute teachers while classroom teachers complete these assessments. Classroom teachers also use WIN time and regular classroom instructional time to meet with every reader. Completing the assessments before school would maximize teaching students at their instructional reading levels in September without waiting until November. Research shows that substitute teachers are not as effective as regular classroom teachers so learning would be maximized and we would save money without needing subs.

### Other Information

We would still be in alignment of required school days because elementary does not require the same number of instructional hours as secondary. This is aligned with Kindergarten meetings that have been in existence in the district.

This would allow community resources to be available for all families.

Other districts use this model including:



# **Support Needed**

- OHA would need to train all teachers 3-5 on administering running records and using them.
- WW would have a refresher training on administering running records and using them to inform instruction.
- We would have a K-5 interrater reliability training
- This assessment administration would be practiced with students.

#### **Strengths**

I like these meetings because it gives the kindergartener one on one time with their teacher before they start for the year. It gave my son a sense of belonging to the classroom and helped him feel connected to his teacher. It is a nice transition to school.

It helped ease my child's nerves, who is usually very nervous about new things!

Gave teachers the opportunity to assess students' skill levels prior to the start of the year

#### Suggestions for Improvement

It was difficult for our family to cover the 2 days prior to kindergarten starting. I had to take one day off of work (the day of his kindergarten meeting/screening) and then take my son to work with me on the second day. He was so excited to start kindergarten, it was hard for him to watch his sister have a first day of school on Tuesday and then make him understand that he had to wait Thursday that week to begin school.

Allow some choice of times for the assessment, or a way to give preferences - at least if it's important. For us, it wasn't a big deal, but for other families it could be a hardship to have the appointment scheduled for them with no chance for input. Maybe don't ask everyone for their preference, but give contact info ahead of time in case it's important - that way only families who have a conflict or difficult scheduling will contact you with their preferences.

It might be nice to have the meetings prior to the start of school, as the kid's usually have day care already lined up.

Have kindergarten start the same day as their elementary peers.
