Last fall as we were discussing our on-going Capital Project work and the creation of the CAPEX scoring document, it was determined that annually the Board of Education would set aside \$150,000 (Capital Projects Fund) for project work identified below a \$100,000 threshold to be addressed over the next four years given the sum total of this work equaled approximately \$649,754 (see attached sheet dated August 26, 2014). The priority #1 projects became our focus for the 2014-15 school year and the need for a stand-by generator at Julian Middle School became the primary focus.

The appropriate legal notice calling for this project work appeared in the February 18, 2015 issue of the Wednesday Journal (see attached copy of legal notice) with a bid opening date set for Tuesday, March 10, 2015 at 1:00 p.m. Also all vendors listed on the requested bid list were sent a copy of the bid specifications (see vendor list). A mandatory pre-bid meeting was scheduled for March 3, 2015 at 1:00 p.m., at which time four firms were present (see sign-in sheet). On Tuesday, March 10, 2015, three of the four firms present at the mandatory pre-bid meeting submitted bids (see bid summary sheet).

We are recommending award of a contract to Evans Electric in the total amount of \$68,580 and will be requesting formal approval at our first meeting in April. While Evans Electric has not previously done work for District 97, Norm has checked references and is confident of their capacity to perform this work. Given that this bid amount is below our estimate of \$100,000, Norm is now preparing a bid specification for the outdoor site lighting project and securing quotes for high water alarm contact work.

In terms of the other priority #1 work identified for this year, Michael Arensdorff has been working with CDW in terms of the broadcast alarm work, across the District, which is being integrated with other technology work. The fire alarm interconnect work has been integrated with the overall electrical alarm work being done this summer. These projects, once completed, will address all priority #1 projects under \$100,000 work.
