The Board of Trustees of Denton Independent School District, State of Texas, met in a Regular meeting at the Denton ISD Central Services building, 1307 N. Locust St., Denton, Texas, on Tuesday, April 22, 2025, at 6:00 PM.

Pledges The Pledges to the flags were led by Martinez Elementary School students.

Presentations/ Recognitions Guyer High School's Benjamin Marshall qualified for the American Invitational Mathematics Exam (AIME); a 15-question, three-hour test given only to those who rank in the top 2.5 percent on the American Mathematics Competition (AMC). The purpose of this exam is to distinguish the top math students from across the country to be members of the United States Math Olympiad Team. The use of calculators is not allowed on the test, with only pencils, erasers, rulers, and compasses permitted. Concepts typically covered in the competition include elementary algebra, geometry, trigonometry, number theory and probability. Benjamin is only the third Guyer student to qualify for this exam, and he is the first student to do so as a junior.

The CoServ Charitable Foundation has been a longtime supporter of Denton ISD. This year, the CoServ Charitable Foundation donated \$35,000 to the Denton Public School Foundation (DPSF). The \$35,000 donation will be used for the DPSF to provide various grants and scholarships to students and teachers. Earlier this fall, the DPSF provided \$151,914 across 145 different scholarships and grants. Those scholarships and grants were awarded to 150 Denton ISD teachers and staff members across 42 campuses.

Discussion of 2025-2026 Budget Jennifer Stewart, Executive Director of Budgeting, provided the Board of Trustees with an overview of the District's Debt Service. The District's historical tax rate has been .48 since 2017-2018 school year. The assumptions the district is using for the 25-26 Debt Service budget are the following:

• 10% Property value growth

- No change in debt service tax rate
- Consider refunds of delinquent taxes
- Based on current debt service obligations

All of these assumptions are based on current law. The 2025-2026 Debt Service estimated revenue is \$182,204,763, 2025-2026 current debt obligations are \$155,062,751 with a variance of \$27,142,012.

Discussion of Remaining 2023 Bond Financing Plan Josh McLaughlin, BOK Financial Advisor provided the Board of Trustees with information regarding the Sale of Remaining Bonds from 2023 Bond Program.

Denton Independent School District has actively deployed various debt management practices to lower the borrowing costs of taxpayers. Such actions have reduced the cost of voter-approved bonds and provided District taxpayers with more than \$316.8 million of direct savings since the year 2005.

Each year, Denton ISD's Board of Trustees is required to set two separate tax rates:

- Maintenance & Operations ("M&O") Tax Rate: Used for the "day-to-day" operational expenses such as teacher salaries, instructional programs, and services, etc.
- Interest & Sinking Fund ("I&S") Tax Rate: Used for annual debt service requirements of bonds approved by voters.

The District's total tax rate has decreased by 31.31 cents over the last five years.

Voters of Denton ISD approved the issuance of \$1,418,481,928 of bonds on May 6, 2023 (the "2023 Bond Program"). The District has completed one (1) sale from the 2023 Bond Program, totaling \$1,036,485,000. Denton ISD has \$381,996,928 of bonds remaining to be sold from the 2023 Bond Program (\$352,307,930 from Proposition A and \$29,688,998 from Proposition B). The District maintains independent bond ratings of "AA" by both Fitch Ratings and by S&P Global Ratings.

Denton ISD issues the \$381,996,928 of remaining bonds from the 2023 Bond Program utilizing a combination of fixed rates and variable rates of interest.

- **Bond Sale No. 1:** \$181,996,928 Utilize fixed rates of interest (the "Series 2025-A Bonds");
- **Bond Sale No. 2:** \$200,000,000 Utilize variable rates of interest (the "Series 2025-B Bonds")

At its Tuesday, May 13, 2025, meeting, the Board of Trustees will consider a "Parameters Bond Order" designating the ability to approve the issuance of the Series 2025-A and Series 2025-B Bonds to the District's Administration.

Discussion of Legislative Update

Dr. Deron Robinson, General Council provided updates and resources to the Board of Trustees regarding the 89th Legislative Session. Denton ISD uses different formats to share its legislative priorities and how they align with our goals. Keeping up with legislative changes and engaging with elected officials can directly impact public education policies. Informing our community strengthens our voice and helps voters make informed decisions. Partnering with advocacy groups reinforces our commitment to supporting public education in Denton.

Discussion of Early Childhood and Pre-K Update

Cecilia Holt, Director of Early Childhood Education, provided the Board of Trustees with information regarding the 2023-2024 school year. This program provides an outstanding instructional program and services for the academic and social and emotional development of children ages birth through age 5 and community support and partnerships for parents. This information for the Early Childhood Education department is for the 2023-2024 school year. The current enrollment for early childhood is 1761 students. Pre-K has 670 students enrolled.

Announcement of Board Operating Procedures

The Board of Trustees must annually announce the name of each board member who has completed the required continuing education, who has exceeded the required hours, and who is deficient in the required continuing education.

President Barbara Burns read the following statement:

The requirements for training are measured as of the first anniversary of the date of the trustee's election or appointment or the two-year anniversary of his or her previous training, as applicable.

There are eight training areas for board member continuing education:

- 1. Local District Orientation
- 2. Orientation to the Texas Education Code
- 3. Post-Legislative Update to the Texas Education Code
- 4. Team Building
- 5. Additional Continuing Education
- 6. Evaluating Student Academic Performance and Setting Goals

- 7. Identifying and Reporting Abuse, Trafficking, and Other Maltreatment of Children
- 8. School Safety

An experienced Board member must complete **five** hours plus the Texas Education Code update after a legislative session as well as **three** hours of Evaluating Student Academic Performance training every two years.
