Thank you for the opportunity to submit this proposal for fire alarm system repairs. Fox Valley Fire & Safety recently performed a fire alarm inspection at the above referenced location. Based on deficiencies identified, Fox Valley Fire & Safety will provide labor and material to complete the following recommendations:

Fire Alarm System Scope of Work:

- The annunciator on the ground floor by exit door 4 and main office is not functioning properly.
- There is an Loop 2 internal fault due to a bad EPROM chip on the fire alarm panel. Due to obsolete parts from the manufacture we will need to replace the annunciator and the fire alarm panel to correct issue.
- Smoke detector in lower level by exit 15 and gym is missing and needs to be replaced
- Pull station by exit door 10 failed and needs to be replaced
- Horn strobe at exterior by dock door 15A failed and needs to be replaced
- Horn strobe in northeast corner of lower level gym is taped and painted, need to be replace
- Need to test fan shutdown on two duct detectors that was not tested due to units not running
