Sheriff Erik Smith reported that he met with County Administrator Mary Catherine Hannah, City Manager Rachel Smolinski, and City Police Chief Eric Hamp to discuss concerns on the number of animals that are brought into the shelter by the city. Deputy Reid reported a year-to-date total of 460 animals brought in from the County and 440 animals brought in from the city. Sheriff Smith will follow up with Administrator Hannah for further discussion and to coordinate another meeting with the city. Motion was made by Commissioner Francisco and supported by Commissioner Fournier to receive and file the Animal Control Report for October as presented. Motion carried.

INFORMATION ITEM: Chair Kozlowski stressed the need for better communication between the Animal Control Shelter and the people that call or email them. He was contacted by two people that were looking to adopt dogs that never received a call back or a return email. Sheriff Smith asked to receive the information and phone numbers after the meeting.
