
## **Heppner High School**

# Riverside High School RHS CAREER EDUCATION

The Career Education Credit at Riverside Jr/Sr High School is the culmination of several years of training/education for Riverside's students in grades 7-12. The credit comes from a combination of the final Senior Project, the Advisor/Advisee Program, and the utilization of the *Career Cruising* program to build a portfolio and plan for each student's future careers. The vision was each child traversing the 7-12 program at Riverside would have one person who kept track of their academic achievement, career goals, personal growth and issues, and helped them deal with problems. The Advisor/Advisee Program grew from this perceived need to meet with students in small groups and provide each student (and their parents/guardians) an adult in the school familiar with them, academically and personally. The law requires that schools have a comprehensive career plan grades 7-12, and it must be in place for Class of 2008.

The Advisor/Advisee program meets each day for half an hour. The advisee reads three days a week and does career activities one day a week. Two programs are utilized in the Advisor/Advisee program: *Career Cruising* for completion of career activities and *Accelerated Reader* Program for improvement in reading. Advisors meet with their advisees every day, but they only have activities planned for once per week. The program is dynamic and multifaceted. The Advisor/Advisee program provides time for the students to investigate careers

and to improve their reading abilities, which is tied to their language arts grade since they receive 15% of their grade from accumulating Accelerated Reading points.

Career Cruising makes the career planning fun and easier. Staff and students (and parents) can access the program from their home computers, so they can explore on their own as well as during the advisee activities during the advisor/advisee period. They need only to log on to *http://careercruising.com* the username is *Riverside* and the password is *pirates*. Then it is a matter of building a portfolio. Students can tell parents their password, or it can be obtained by calling Ms. Thomas or Mrs. Donna Barton at Riverside. Most of the first year is devoted to students completing their career plan activities. Each student builds an individual career exploration portfolio in Career Cruising over the course of time at Riverside. The advisor provides documentation of the plan as each student exits as a senior. The Advisor/Advisee Program is evaluated yearly and ideas for team building, improvements or any other thoughts are incorporated.

The Senior Project and exit interview is the culminating activity for the Advisor/Advisee Program. All advisors serve on the committees for the exit interview. The senior presents and defends his/her project to the committee. The project includes a resume, attendance profile, disciplinary issues, testing records, CIM scores, community service, job shadows, employee evaluation forms, the Career Cruising Portfolio, any other pertinent information, and official transcripts. Students present evidence that they have the appropriate skills and are ready for whatever path they choose beyond high school, whether that be the military, college, university, vocational school, or the business world. The best part of the whole project is it instills students with skills and prepares them for interviews they will encounter as they go out in to life. The senior project is evaluated yearly, incorporating suggestions and ideas to make it more worthwhile and beneficial for students.

Fifth Grade Math

7% have exceeded their benchmark 64% have met their benchmark

Sixth Grade Reading

10% have exceeded their benchmark 64% have met their benchmark

Fifth Grade Reading

7% have exceeded their benchmark 53% have met their benchmark

## **Morrow Education Center**

We near the end of March with 80 students currently enrolled, 46 of which are Morrow County students. As spring break rapidly approaches, students at MEC are trying to focus on sustained progress and academic growth. The third quarter is winding down and students are anxious for spring break to begin.

The MEC staff continues to demand growth in the fields of academics, attendance and behavior. While credit recovery is often a necessity for MEC students we also offer a wide variety of classes using multiple delivery methods. We continue to enjoy the classroom here at MEC and welcome the daily challenges that go along with the program. We are committed to serving the students of Morrow Education Center and providing a safe alternative learning environment for all students to thrive in. We appreciate your support of this program, and your commitment to all students of the Morrow County School District.

# **Special Education**

We have had continued activity in the three weeks since our last report, but not many new items to report. This time of the year special education teachers are preparing for parent-teacher conferences and trying to complete extended assessments, which replace TESSA tests for students not able to take the regular test and the CLRAS (Career and Life Related Assessment System) for students that are unable to take any tests. These tests have to be given individually which takes a lot of time, but must be done because they reflect on our participation score.

We finished entering the data on our file review to the state. Earlier in the year all of the special education teachers met for a review of special education files. We had to report on 95 criteria from eight files selected by ODE to show we were in compliance. In general there were a few errors, some of which occurred because a student came to us from another district with errors in their records.

From the data turned in on the census, ODE also required districts to submit field reports on areas that they determined suspect. Our district did very well here. There were only a few areas flagged. We had a higher than average number of students listed for specific learning disabilities and a lower number listed for Emotional Disturbance. Because of our demographics, those were easier to explain. We were also flagged in the area of "low identification because of ethnic background" for Asian, Black and Native Americans. (That was the easiest to explain since we are below 1% in all of those areas.) The next challenge after spring break is when the state will return their findings on our file reviews and I will need to write our Special Education District Improvement Plan. I don't think we will be found non-compliant in many areas.

## ELL Program

30 Day Response to the ODE ELL Audit

We were given 30 days to respond with program changes to the six findings to our Title III ELL audit review. With that, the ELL director met with school district administration and school principals to make plans as to how each school will respond to the audits corrective actions. Principals were retrained in the ELL student exiting process for it was a requirement of one of the audits stipulations. By March 17<sup>th</sup> the ELL director was able to adequately and properly bring every response of the corrective changes of the Title III audit and meet with the assistant superintendent. As of March 22<sup>nd</sup>, every piece of our responsibility was met, and mailed back to the Oregon Department of Education assuring

them of our legal compliance to their findings relating to our Title III program. The State is now required to audit every Title III school district's program in a small review every year. Every six years they are now required to do a major audit like the one we have just foregone.

# Day of Talk, Planning, Vision with ELL Site Coordinators

With so much that our ELL program has forgone before the audit, and after the audit. And with the major structural change that we have made in the programs authority centralization, curriculum and the focus of ELD achievement, the district office and I planned a day to meet with all our ELL teachers, and talk. We discussed next year's vision and program change, curriculum. We shared ideas of how to teach reading, writing, speaking and understanding to ELL students. We shared the immediate changes that each school had to make in order to meet the audit's findings. It was a time to settle ourselves and focus back to what was most important. With this I have still called our ELL staff to help me create, out of all this constant intensive change, the best ESL program in the state of Oregon. It was a day well spent.

## **ELPA Testing**

We have been getting ready for the new state mandated testing program called the ELPA English Language Proficiency Assessment. It has never been field tested, but half of the ELL students in the state have to do it, the other half are to be tested by the district's commercial test. It has required us to be trained, practice tested with ELL students, computer diagnostic checks, headsets with microphone prepared, registrations as district testing coordinators and a variable of many other smaller things. It does not make our job easier, for it conflict with our TESA testing periods and regular instruction. Our State has been mandated by the Federal government that they must have had this test in place by the spring of 2006. And that time is now.

## Re-Focus of ELL Student Achievement

With all that we are hit with in administration and school challenges it's important to remember what the real purposes are. They are not to just satisfy paper work for compliant programs or make everything just look better organized. It is still the kids. I am self challenged to get the best instruction, by the best teachers, with the best curriculum, and the best vision of championship leadership, so that we have a clear road paved ahead of us to help our ELL kids achieve high levels of English academic success. It has been done, and it is being done. I too want to bring us into those Halls of Academic Fame, of what we have done, here in the dessert.
