3.A Reports & Presentations

- Social Studies Field Trip Request: IJSH social studies teacher, Ricky Fay, made a presentation on a trip he would like to take his US History students on, to the east coast in the summer of 2011. He had an itinerary that included such sites as: Washington DC, Gettysburg, New York City, Boston, etc. With board approval, he and his class have plans to raise the money throughout the year.
- **PLC Day:** Superintendent Burrows reported on the PLC staff development that was held on September 24th; Teachers are excited and the feedback has been positive.
- Common Core Curriculum: Reported that the state board of education is meeting 10-28-10 and will likely work on common core curriculum, which is a national curriculum that may be adopted. If they adopt this national curriculum, by 2014 our teachers will be teaching to a new set of standards.
- **School Finance:** The state school fund is at \$5.736 billion and holding which is about where we were 2 months ago. The budget will get us through this year, but is a 9% decrease from last year.
- State Report Cards: all schools were satisfactory with HES and HHS being named Outstanding Schools; ACH missed the Outstanding rating by 1 point. RHS received a couple different awards last year for student achievement, yet they were judged as satisfactory. The good news is that across the area, our schools compare favorably.
- SBE School Report the Butterfly Garden: A beautiful presentation was made by Marjorie & David Park on the butterfly garden that was made in memory of longtime SBE teacher, Beth Creason. The students and staff took part in the construction, as well as the Boardman Gardening Friends and the Boardman Public Works. It is a wonderful addition to the landscape of the school.
- Attendance Variance Report: Two new variances were approved by the superintendent as per policy.
- **Principal Reports**: Riverside HVAC is nearing completion with the elevator to be completed within the next 3 weeks; College reps coming to RHS Mrs. Jimenez has done a great job getting so many colleges to come to RHS this has been very successful; Next year, there is a possibility of expanding it to other schools in the area.
