(Public Act 102-0791) (105 ILCS 128/45)

Each school district must implement a threat assessment procedure that may be part of the school board policy on targeted school violence prevention. The procedure must include the creation of a threat assessment team. The team must include **ALL** of the following members:

- An Administrator employed by the school district or a special education cooperative that serves the school district and is available to serve.
- A teacher employed by the school district or a special education cooperative that serves the school district and is available to serve.
- A school counselor employed by the school district or a special education cooperative that serves the school district and is available to serve.
- A school psychologist employed by the school district or a special education cooperative that serves the school district and is available to serve.
- A school social worker employed by the school district or a special education cooperative that serves the school district and is available to serve.
- At least one law enforcement official.
