Laida P. Benavides: This is to refinance some maintenance tax notes that we have, that we issued back in 2008. Our financial advisors are always running the numbers and seeing if the market is there to re-issue, or refinance, and so they were able to find opportunity to refinance about \$3.7 M and with lower interest rates. I just wanted to point out that the administrative staff that you are giving the authority to would be Mr. Santos, and myself, that once they are able to price our Bonds, we pull the trigger we do all the signatures, and that's the authority your giving us tonight. Like parameters, we're setting parameters on what we would be authorized to do. That's what both Items do tonight.

Laida P. Benavides: This is the last Series of the 408 M dollars; we have Robert Tijerina here from "Tijerina, Galvan & Lawrence". Their our financial advisors and they ran some scenarios for us, so later on, probably by August we'll have a preliminary amount we need for a tax rate and we'll bring that. But this should take care of all our building needs that were identified by our Blue Ribbon Committee, more than 6 years ago. We think the Market itself.... The Federal Reserve is keeping rates low so we want to take advantage of that. Again, unless anybody has a specific question we have Mr. Tijerina here.
