### RE: 2013 Bond Project: Bid Package T9 Bid Summary

Dear Mr. Francis,

When Bid Package T1 was awarded in 2014 the new wireless standard was 802.11ac Wave 1 with Wave 2 anticipated during the project implementation. That project included upgrading the middle and high school access points to Wave 2 when Cisco released their Wave 2 upgrade module; however, that module was never manufactured. Instead, Cisco offered a trade-in credit for the Wave 1 access points. After reviewing options the project team decided to issue a bid to leverage that credit and leverage potential credit from the Universal Services Fund (e-Rate) program to upgrade the wireless infrastructure to Wave 2 district-wide and replace the controllers and management tools whose maintenance and licensing will expire in 2018.

Bid documents were issued for Bid Package T9 which includes the installation of Wave 2 access points at all buildings. In addition to contacting known interested bidders, bids were advertised on the state bid website, Livonia Public Schools website, Universal Service Fund website, and in the local paper. Bids were received and publicly opened on November 13, 2017.

## **Bid Evaluation Summary**

After a review of the bid proposals received, the project team of Barton Malow and Livonia Public Schools technology staff conducted a post-bid interview with the low bidder to verify their proposal was inclusive of the scope of work and schedule, evaluate both alternates and voluntary alternates, consider the benefits of each solution proposed, and gather information on related experience. The attached bid tabulation indicates the bid pricing received and mandatory alternates. Based upon the evaluation of the project team, we present the following company for consideration by the administration and Board of Education.

# Total Project Cost with E-Rate and Deduct to Existing Contract

The cost will be partially offset by a \$109,901.00 deduct to their existing contract for the Wave 2 modules and switches that were part of their original installation and a potential of approximately \$400,000 in e-Rate reimbursement bringing the project cost to approximately \$375,000.
