#### 1. Call to Order:

#### 9. Principal's Report:

a. Sports (Basketball): Both our boys and girls basketball teams played against the Noorvik Bears and Kivalina Qaviks. The boys lost both games; our girls won both games. Since our high school students are under the 30 count, 8<sup>th</sup> grade students are allowed to play with the high school, which will not effect their high school basketball. Since we have so few high school students, and we also have a MS/Coed BB team, some 8<sup>th</sup> grade students are choosing to play with the HS students. In that case, we

didn't' have enough eligible middle school basketball players to travel last weekend. The HS boys and girls teams will be traveling the next 3 weeks to different villages. Because grades are run every 2 weeks and the grades were run 1/30/23, some middle school team did not have enough eligible students to travel to Selawik last weekend. 2/13/23 is the next date to run grades for all ball players. Because the Principal from Noorvik had to help in Kobuk, Mike Ziebell was hired as the Principal in Noorvik. He would like a basketball tournament held in Noorvik sometime this month. Kiana is to host the MS COED games on 2/24-25/23. Mr. Stewart will sacrifice the Noorvik tournament because of the MS COED tournament. Will possibly keep some middle school boys and girls here so they will have enough players for that tournament.

#### b. Attendance:

8/9/22 to 12/16/22 for PK(4) to 7<sup>th</sup> grade is at 75.79%. For 8<sup>th</sup>-12 grade is at 72.57%. Our attendance has been low. We need help with ideas on how to get students to school. With your permission, I will announce on VHF to get your students up to attend school. One incentive is an "Excellent Attendance" award. Will have the award at the Next award ceremony. The parents will also get an award as they helped get their Child/children to school.

#### c. Parent/Community Involvement:
