ACADEMIC ACHIEVEMENT GRADING/PROGRESS REPORTS TO PARENTS

EIA (LOCAL)

RELATION TO ESSENTIAL KNOWLEDGE AND SKILLS The District shall establish instructional objectives that relate to the essential knowledge and skills for grade-level subjects or courses. These objectives shall address the skills needed for successful performance in the next grade or next course in a sequence of courses.

Assignments, tests, projects, classroom activities, and other instructional activities shall be designed so that the student's performance indicates the level of mastery of the designated District objectives. The student's mastery level shall be a major factor in determining the grade for a subject or course.

GUIDELINES FOR GRADING

The Superintendent or designee shall ensure that each campus or instructional level develops guidelines for teachers to follow in determining grades for students. These guidelines shall ensure that grading reflects student achievement and that a sufficient number of grades are taken to support the grade average assigned. Guidelines for grading shall be clearly communicated to students and parents.

KINDERGARTEN

Achievement or progress in kindergarten shall be reported by a performance checklist.

GRADES 1-5

In grades 1–5, achievement shall be reported to parents as:

- 1. Number grades for language arts, math, science, and social studies.
- 2. S, N, and U for fine arts, health, and physical education.

GRADES 6-12

In grades 6–12 the District shall report progress to parents as numerical scores.

NUMERICAL VALUE

The following numerical values shall be used for letter grades transferred into the District:

A + = 97	B+ = 88	C+ = 79	D+ = 74
A = 94	B = 84	C = 77	D = 72
A- = 91	B - = 80	C- = 75	D- = 70

PROGRESS REPORTING

Grade reports shall be issued every six weeks on a form approved by the Superintendent or designee. Performance shall be measured in accordance with this policy and the standards established in EIE.

INTERIM REPORTS

Interim progress reports may be issued at the teacher's discretion; however, notice of a student's consistent unsatisfactory performance shall be issued in accordance with law.

CONFERENCES In addition to conferences scheduled on the campus calendar, con-

ferences may be requested by a teacher or parent as needed.

ACADEMIC DISHONESTY Students found to have engaged in academic dishonesty shall be subject to grade penalties on assignments or tests and disciplinary penalties in accordance with the Student Code of Conduct. Academic dishonesty includes cheating or copying the work of another student, plagiarism, and unauthorized communication between students during an examination. The determination that a student has engaged in academic dishonesty shall be based on the judgment of the classroom teacher or another supervising professional employee, taking into consideration written materials, observation,

or information from students.

RECORDING FAILING GRADES

The District shall record a 50 in the permanent cumulative record for any average numerical grade that is lower than 50.
