HB3 Goal #3 CCMR & Targets

HB3:The percentage of graduates that meet the criteria for CCMR will increase from 48% to 90% by the class of 2028 - (Class of 2023 - 55%, Class of 2024 - 65%, Class of 2025 - 75%, Class of 2026 - 80%, Class of 2027 - 85%, Class of 2028 - 90%)

GPM 3.1:The percentage of graduates that meet TSI compliance in English and Math through the TSIA, SAT, ACT, or the English and Math College Prep Course will increase from 32% to 60% by the class of 2028.

Overall HB3 CCMR Goal - We are almost on track.

For Class of 2025 - The plan moving forward is...

- GPM 3.1 We are on track. 24% is our current number. We will see a large increase at the end of the year.
- GPM 3.2 We are not on track. New master scheduling process and MHS merge will allow for more student access to dual credit courses. Our intentional focus on TSI interventions 8th-12th grade will ensure we get back on track in the future.
- GPM 3.3 We are on not on track in short term. We have worked to clean up the pathways and better align them to industry based certifications. Cohort 2028 and 2029 will have much larger IBC numbers.

NEXT STEPS

- Implementation of Mastery Prep (TSI/SAT/ACT) across secondary campuses
- High school teachers (11th-12th) embed TSI/SAT/ACT prep in core content classes
- Elementary implementation of Beable & Progress Monitor Middle School Implementation
- Continue to build and use systems to track and verify student
 CCMR pathways and data and link to Special Education ARD transition meetings
