1. Provide a DETAILED RATIONALE explaining how the waiver will enhance student learning opportunities, promote innovation or increase equitable access to effective teachers. Include information about the problem or obstacle, if any, the waiver will help the district overcome.

The Sheridan School District of the Arkansas River Education Service Cooperative are collectively and separately requesting a waiver from A.C.A. 6-10-106, which establishes the first allowable day of class as the Monday of the week that contains August 19. For the 2024-2025 school year that date will be Monday, August 19. We would appreciate approval for the early start date for the listed schools in our region giving public schools the equity afforded to Charter Schools.

The specific waiver being requested is to allow the applying school districts to set their individual district's first day of class to be "no earlier than Monday, August 12."

The law as presently constructed results in a wide swing in the allowable opening date of school. At the earliest, it can be August 14, which was the case this year- fall of 2023. The latest possible first day is August 20 which, under the law, will be the fall of 2029. This waiver would allow the school to open next year and years to follow on the same relative date as this year.

The advantages of this waiver are several:

The fall and spring semesters would be closer to the same length. Without this waiver, the fall semester will be 84 days while the spring semester will be 94 days, a difference of 10 days. With the waiver the fall semester will be 91 days and the spring semester 87 days, a difference of only 4 days. The more unbalanced the semesters are, the greater the issue for classes that are one semester in length.

- 2) The alternative solution for unbalanced semesters is to not end the fall semester until after Christmas break. This results in final exams shortly after two weeks out of school, and the possibility of exams being repeatedly postponed due to winter weather.
- 3) This waiver will give greater assurance of school ending in late May rather than extending into June. Some research indicates a decrease in learning past the Memorial Day Holiday.
- 4) Beginning school earlier automatically results in more days of instruction before spring testing. More days of instruction will result in higher test scores,
- 5) Activities such as football will begin next fall on the same relative date as they did this fall, with or without the waiver. Therefore a large number of students will already be on campus to practice and prepare for their activities, regardless of the opening date of school. In addition to students who play football, this would include students who participate in groups such as golf, tennis, cross country, volleyball, band, cheer, dance, ROTC, Student Council, and National Honor Society, as well as others.

2. Provide a detailed explanation of how the services being waived will be provided for students.

The school district will create a calendar with an earlier start date which will provide them with more flexibility throughout the school year. The school year will remain the same length. It simply allows a district to continue with a school calendar structured as closely as possible to the current one and avoids the dramatic change to the calendar which must result without the waiver.

3. Provide a detailed explanation of how the district will monitor and evaluate the effectiveness of the waiver.

The district will monitor student assessment results and student attendance data related to the earlier start date to determine the effectiveness of the early start date.

SSD 2024-25 School Calendar Survey Results

Sheridan School District certified and classified personnel were surveyed Feb. 2-6 regarding two options for the 2024-25 school calendar. These two options were chosen for the survey by the Personnel Policy Committee (PPC & CPPC), following input from District families, faculty and staff.


<u>Option A is an alternate calendar</u> with a start date of August 19 and end date of May 23, the Friday prior to Memorial Day. The school day would be 8:00-3:20, and there would be 173 days of instruction.

<u>Option B is a traditional calendar</u> with a start date of August 12 and also has an end date of May 23. The school day would be 8:00-3:10, and there would be 178 days of instruction. (*Note: Because the traditional calendar has a start date of August 12 – instead of the August 19 date required by state law – its selection would require a waiver and would be pending State approval during the month of March.) Holidays, parent-teacher conferences, and built-in Professional Development days are identical in both calendars.*

Approximately 86.7% of certified staff and 66.3% of classified staff chose Option A.


Certified Staff Responses

Resolution

In Support of a Waiver Request Affecting the Allowable First Day of School

A.C.A 6-10-106

WHEREAS Arkansas law, A.C.A 6-10-106, provides for the school year to begin no earlier than the Monday of the week containing August 19; and

WHEREAS under this law, A.C.A 6-10-106, the start of school varies from year to year, beginning some years as early as August 14, or as late as August 20; and

WHEREAS under this law, A.C.A 6-10-106, the earliest school can begin is August 19; and

WHEREAS a late start to the school year creates unbalanced semesters, reduces the preparation time for state testing, and limits flexibility in scheduling inclement weather make-up days;

THEREFORE be it resolved that the Sheridan Board of Education endorses the Superintendent's waiver request affecting the allowable first day of school on August 12, and recommends its approval by the Arkansas State Board of Education.
