The Board of Trustees Maywood School District 89

A Regular Board Meeting of the Board of Trustees of Maywood School District 89 was held Thursday, November 8, 2012, at 6:00 PM in the 906 Walton, Melrose Park, IL 60160.

1. The Regular Meeting of the Board of Education of School District 89 Maywood-Melrose Park-Broadview came to order at 6:24p.m. on Nov. 8, 2012.

4. Presentation

A. Excess Food Donations

Marisa Raymond, Food Service Coordinator presented a pilot program in place at Jane Addams where excess breakfast foods are being collected and donated to a food pantry at St. Eulalia Church in Maywood. Mr. Gabriel Lara from St. Eulalia spoke of the benefit of this program to the church's food pantry. The Church is able to offer the excess cereals, cookies and juices to the community once a week supplementing the once a month main food distribution. Marisa stated the program will be implemented throughout the District one school per week in the future and the food will be donated to Mount Carmel and Sacred Heart.

B. Healthy Kids for Breakfast Grant

Marisa Raymond announced that each school in District 89 was awarded \$2,500 grant under the Healthy Breakfast-4-Kids program sponsored by Food Family Farming Foundation and Walmart Foundation. The grant money is available and will be used to purchase food service smallwares or equipment for each school. Marisa is working with Preferred Meals to determine, by school, what equipment is needed.

C. Mastery Academy Charter School - Dr. Lee

Dr. Elaine Lee presented an overview of the Mastery Academy Charter School proposal. Board members received proposal documentation during the presentation. Board members had various questions ranging from economic viability, location (unoccupied H. McNelty School in Melrose Park), ADA

compliant location, STEM curriculum, hiring and training of teachers, ensure / measurement of stated goals and funding sources. The Board questioned Dr. Lee about funding sources. She would not disclose funding sources stating that she is not at liberty to disclose names at this time. Dr. Lee stated that the proposal documentation contained answers / explanations to many of the Board's questions. Board members will review documentation and requested that Mastery Academy Charter School return to answer any additional questions at the December 13th Board of Education meeting.
