Re: Superintendent Informational Report

Legislative Update: House Bill 3772

House Bill 3772, which proposed prohibiting the use of suspension or expulsion for students in early childhood through grade 2, was not enacted during the recent legislative session.

It is anticipated that similar legislation addressing student discipline in early grades may be re-introduced in the future. Proactive monitoring of any such proposals will be essential. This will allow the district to engage in advocacy and ensure that any enacted legislation effectively balances the developmental needs of students with the necessity of maintaining a safe and orderly learning environment for all students, families, and staff.

Class Size and Structure Task Force Update

The Class Size and Structure Task Force met on November 5. The team analyzed a report on class size research, evaluated district-specific recommendations, and began planning regarding the scheduling and structural implementation of the recommendations. The presentation used during this meeting is attached for the Board's review. The team's next session is scheduled for December 10, where this work will continue.

SACEE Committee Update

The Superintendent's Advisory Committee on Equitable Education (SACEE) met on November 10 to design a qualitative feedback initiative.

This initiative will focus on gathering insights into the student experience through small-group interviews with 5th and 8th-grade students. The committee formulated a set of interview questions, which will be piloted with committee members' children at the next meeting. Data gathered from these interviews will be instrumental in identifying opportunities and informing strategies to further enhance the student experience across District 103.
