McGuire reported that the Cooperative has one active case of Covid at this time. STEP Open House on May 4<sup>th</sup> was met with positive feedback. Staffing in all programs continues for the 22-23 school year. Select staff will complete Restorative Practice Training through MDE over the summer and fall. LCSI training will occur over the summer, and ALEX is adding the Performance Tracking System in the fall. ALEX and SUN staff will be joining the Behavioral and Emotional Success through Teaching program ("BEST") in partnership with Region 10.

#### B) Enrollment Report

CVSEC currently has 79 students. Incoming enrollment projections have the Cooperative starting with 98 students in the fall.
