Subject: **Permission for Heart Butte School Bus to Enter District #9 Route #2 2017-18 SY**

Description: Heart Butte bus enters our district on route #2 to pick up students to attend school in Heart Butte. Route 2 is the Old Agency route. Route 2 comes approximately 16 miles into our district on the old agency road.

Justification: I have been approached by the Blackfeet Tribe on working together with surrounding communities in the best of our children. I am recommending that the Board of Trustees reconsider the request to approve the Heart Butte route #2 in the best interest of our students to promote positive relationships.

Financial Impact: We do not have to pay individual transportation contracts to the students who ride these routes. This saves us money and we do not have to operate a bus for these areas, which are quite a long distance for us.


Dear Board of Trustee's


Dear School Board,

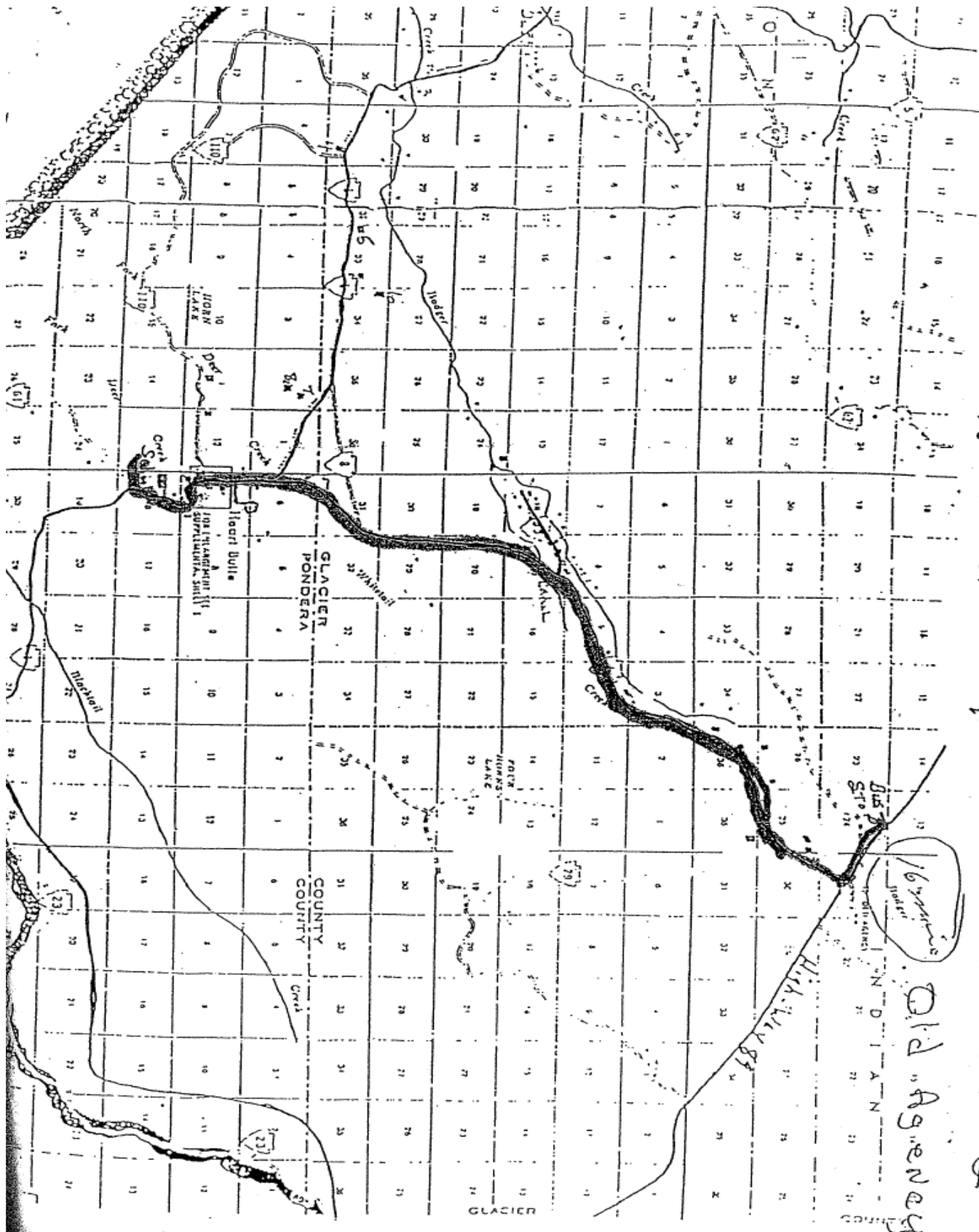
