Dr. Shaver and Mrs. Clifton wish to enter a contract with Education NorthWest. The Microsoft Corporation and the Corporation for National & Community Service have launched a new initiative to promote student leadership in the classroom. Six schools throughout the nation have been selected to participate in the Service & Technology Academic Resource Team (START). Participation includes receiving \$10,000 for use with this initiative and also trip expenses of \$3,912 for the Washington DC kick-off meeting held in January 2010. The other five schools selected to participate were in California, New York, North Carolina, Pennsylvania and Virginia.

**AVAILABILITY OF FUNDS:** It is expressly understood that the fulfillment of the conditions of the Agreement between Customer and Vendor is conditioned upon the receipt of governmental funding, and that any cessation or reduction of such funds shall constitute grounds for termination of the Agreement. In the event of the contingency herein described, the Agreement shall terminate on the last day for which funds were available, without penalty or expense to Customer of any kind whatsoever, except as to payment for services or performances actually received or rendered for which funds exist.
