What?

Include 3 late starts into the 2021-22 calendar.

Why?

Ongoing professional learning and collaboration at times when teachers need it to inform and personalize instruction.

When?

Professional Learning Adjustment

- Move April 8 Professional Learning to Oct. 20.

Why? Earlier professional learning has a greater impact student on learning

How?

- Communicate to families in advance so they can plan appropriately.
- Busses would run 2 hours late.
- This would provide staff with 2 ½ hours of uninterrupted professional learning 3 times a year and provides a model that supports better implementation of professional learning throughout the year.
- Communicate with families exactly what we are working on.
- MAC would plan activities similar as non- school days for MAC families only. (20% of students)
- Community Ed provides 3 hour classes- Scholarships could be granted for families who cannot financially support them.
- PTO could run card sharks and/or strategy games

Other Information

This would still keep us within our minutes of instruction with e learning days.

The late starts would reduce hours by 6 hours.

ACT testing will be for 11th only. (1 day less for grades 9, 10, 12)

172 student contact days. We have 2 additional days built in for snow days.

193 teacher contracts including 8 holidays, 9 professional time, 4 conferences.

If we are short time, we would cancel the Spring Late Start

Other Options Considered

Early release- not optimal time for professional learning, aligns with research that 6-12 students require more sleep.

Full day- Need minutes required in case of snow days when unable to do e-Learning.
