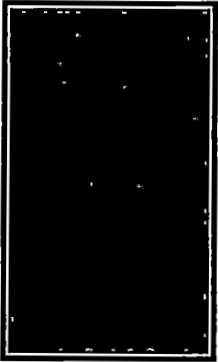

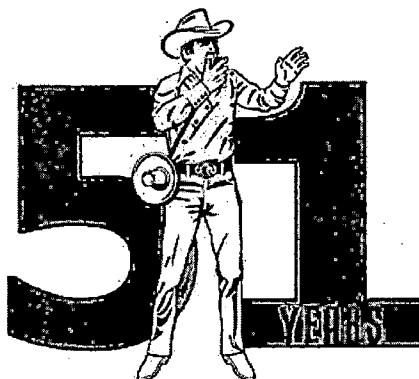
385 South (Andrews Hwy.): Turn right on to 10th Street headed west go about 4 or 5 blocks the Food Service building set on the right side the street.
