Presentations/ Recognitions

Members of the LaGrone ATC Law Enforcement Post 518 finished their state level competition at The University of Texas at Arlington this past July.

Exploring is a program designed by Learning for Life (a sub-division of the Boy Scouts of America) for young adults, both male and female, ages 14 -20 that share an attraction to a specific career such as law enforcement.

The Denton Airport is the 7<sup>th</sup> busiest airport in Texas and is the 89<sup>th</sup> busiest airport in the U.S.

Bilingual/ESL
Update

Teresa Luna Taylor provided the Board of Trustees with an overview of c/Dual Language/ESL Programs and translation services provided by the department. The report showed that Bilingual/Dual Language students are closing the gap in their STAAR English Math performance and are scoring the same or above the ELLs in state of Texas. Data indicates that the performance of Denton ISD bilingual/ESL students continues to excel after program exit and the number of students exiting the program has continue to increase every year for the past

three years.

Bilingual/ESL department provided translation services both oral and written for campuses and departments. Over 800 documents were translated over the past year.

Bilingual/Dual Language students are performing the same or above the state in STAAR performance. Bilingual/ESL department is seeing academic success of exited students in STAAR performance and an increase of exited students in comparison to previous year

Discussion and Review of District of Innovation Policies The Texas Legislature amended the Education Code to empower school districts to enjoy some of the same flexibility given to charter schools by allowing the district to be exempt from certain requirements imposed by state law. Essentially, the DOI legislation is about offering districts local control. The District of Innovation Plan was approved by the Board of Trustees on January 17, 2017. The policy changes presented are a reflection Denton ISD becoming a District of Innovation.

Quarterly Growth Report 2<sup>nd</sup> Quarter 2017 Rocky Gardner with Templeton Demographics presented 2<sup>nd</sup> Quarter Growth report. This report provides a summary concerning the general DFW housing market, economic indicators, Denton I.S.D. residential activity and enrollment projections as of the 2nd Quarter 2017 and its impact to the overall growth of the Denton ISD. This report will give the Denton ISD Board of Trustees an understanding of trends in residential home sales, multi-family occupancies and growth in student population. The average price of homes in Denton is \$258,400 with the median price of \$244,500 with a 2.1 month of supply. Denton ISD can expect an increase of approximately 4,300 students during the next 5 years.

10-Day Enrollment Update Darrell Muncy, Director of Student Support Services provided the Trustees with Denton ISD monitors the 10-day enrollment figures annually. Denton ISD closely monitors the attendance figures at each campus during the first 10 days to regulate student movement and determine under/over populated schools. The District has increase 624 students from the 10<sup>th</sup> day enrollment of last year in 2016.
