

RESOLUTION CALLING FOR ANNUAL TRUSTEE ELECTION

WHEREAS, in accordance with Section 33-503 Idaho Code, the Board of Trustees of Minidoka County Joint School District #331 shall cause to be conducted its Annual Trustee Election on the 3rd Tuesday in May (May 20<sup>th</sup>, 2008) for the purpose of electing a Trustee for Zone #3 and a Trustee for Zone #5.

NOW, THEREFORE, be it resolved by the Board of Trustees of Joint School District No. 331, Minidoka, Cassia, Jerome, and Lincoln Counties, Idaho, as follows:

**Section 1.** That on said date the polls shall be opened between the hours of 8:00 a.m. and 8:00 p.m.

**Section 2.** That said election shall be held as specified in the **Notice of Trustee Election**, attached herein.

NOTICE IS HEREBY GIVEN: That an election shall be held on Tuesday, **May 20<sup>th</sup>, 2008**, and the polls of said election will be open between the hours of **8:00 a.m. and 8:00 p.m.**, within said district for the purpose of electing a school **Board Trustee for Zone #3** and electing a school **Board Trustee for Zone #5**, pursuant to Idaho law.

**Polling** place for Trustee Zone #3 shall be:

Persons seeking election to the position of Trustee for either trustee zones shall be subject to the provisions of this **Notice**.

Any person legally qualified to hold the office of School Trustee for Minidoka County Joint School District No. 331, Trustee Zone #3 or Trustee Zone #5 may file a Declaration of Candidacy for that office.

**Declaration of Candidacy** forms are available at the School District Office. Declarations of Candidacy meeting all legal requirements shall be filed with the Clerk of the School District located at the School District Office, 633 Fremont Avenue, Rupert, Idaho no later than 5:00 p.m., Friday April 18<sup>th</sup>, 2008.

**Section 3.** That said election shall be conducted as other school elections and the polling places for said election shall be as follows:

Acequia Elementary, 20504 4<sup>th</sup> Street, Acequia, Idaho  
Lola Nelson Residence, 120 North 500 East, Rupert, Idaho (Cassia County)

**Section 4.** That no person shall vote at such trustee election who is not at the time of election:

1. A United States Citizen, a **Qualified Elector** of the district and a qualified elector of the trustee zone, for at least 30 days preceding the day of election, and 18 years of age or older, within the meaning of Article 6, Section 2 of the Idaho Constitution; and Chapter 4, Title 33, Idaho Code, and

2. A bona fide resident thereof.

**Section 5.** That no person shall be permitted to vote at said election until such person shall have executed in writing immediately before voting, an **Elector's oath** attesting that he or she possesses the qualifications of an elector prescribed by Section 33-405, Idaho Code, and shall be in substantially the attached form.

**Section 7.** That immediately following the close of the polls, the Board of Election shall compute the results of the election, making the count in public view, and shall immediately within not more than three days thereafter make return of the election to the Chairman of this Board of Trustees, upon forms to be supplied by this Board, and must transmit therewith to this Board all elector's oaths and all ballots cast or rejected thereby. The returns of election, elector's oaths and the ballots shall be transmitted under seal. This Board of Trustees shall thereupon canvass such returns at a meeting to be held for that purpose at the regular meeting place of the board, at the next appointed time, and the person receiving the greatest number of votes cast within the zone shall be declared by the Board of Trustees to be the Trustee from that Zone.

**Section 8.** That the Clerk of the Board of Trustees shall have posted and published the **Notice of Deadline for Filing Declarations of Candidacy and Notice of Election** which is substantially in the attached forms. See Section #2 above.
