AGENDA ITEM: Nomination for Director of Parker County Appraisal District

ALIGNS TO BOARD GOAL(S):

6. Provide resources and facilities consistent with the growth of the District.

BACKGROUND INFORMATION:

- Every two (2) years members of the Parker County Appraisal District (PCAD) Board of Directors are elected. The next two-year term begins January 1, 2012.
- The PCAD Board of Directors is comprised of five (5) members who govern the appraisal district by establishing policies and procedures for the PCAD's organization and operation.
- To be eligible to serve on the PCAD Board of Directors, a person must be a resident of the appraisal district and must have resided in the appraisal district for at least two (2) years immediately preceding the date of taking office.
- An employee of a taxing unit is prohibited from serving as a director unless the employee is also an elected official or member of the governing body of a taxing unit that participates in the appraisal district.
- Each voting tax unit in the PCAD has the opportunity to nominate one (1) candidate for each position to be filled. Therefore, the Aledo ISD may nominate from one (1) to five (5) candidates.

ADMINISTRATIVE CONSIDERATIONS:

- Two years ago, the Aledo ISD nominated Mr. Gary Aguillard as a candidate.
- Mr. Aguillard was subsequently elected to serve on the PCAD Board of Directors.
- Mr. Aguillard has been contacted and has agreed to serve another two-year term if nominated and elected.
- Mr. Aguillard's resume follows for your review and consideration.

RESOLUTION NOMINATING CANDIDATE FOR THE PARKER COUNTY APPRAISAL DISTRICT BOARD OF DIRECTORS, PARKER COUNTY, TEXAS

Be it remembered that at a regular meeting of the Aledo Independent School District, a political subdivision of the State of Texas, held on the 17th day of October, 2011, said meeting having been duly called in accordance with the laws of the State of Texas and the rules and regulations adopted by the Aledo Independent School District, and a quorum having been present at said meeting, upon motion duly made and seconded, the following resolution was adopted, to wit:

WHEREAS, Section 6.03 of the Texas Property Tax Code provides that each taxing unit that is entitled to vote may nominate by resolution adopted by its governing body one candidate for each position to be filled on the Board of Directors of the Parker County Appraisal District; and
