AGENDA ITEM: Consider Acceptance of Certification of Unopposed Candidates and Approval of Cancellation of Trustee Election on May 6, 2023

BACKGROUND INFORMATION:

- As stated in Board Policy BBB (LEGAL), the Board of Trustees consists of seven members serving terms of three years, with elections held annually.
- The terms of one-third of the Board Members, or as near to one-third as possible, expire each year.
- Election of Board Members is by position or place in accordance with Texas law.
- An Order of Election was approved by the Board of Trustees on January 17, 2023 for a Board of Trustees Election to be held on May 6, 2023.
- The deadline for interested parties to file an application as a candidate, or as a write-in candidate, for the May 6, 2023 election passed with only two applications received.
- Applications were received from Zach Tarrant, Place 6, and Hoyt Harris, Place 7.
- Texas Election Code Sections 2.051, 2.052, and 2.053 provide for declaring unopposed candidates elected to office and cancellation of an election.
- The following documents, Certification of Unopposed Candidates for Other Political Subdivisions (Not County) and Order of Cancellation of Trustee Election on May 6, 2023 have been prepared in accordance with these provisions.
- Although the Board of Trustee election is being cancelled, the Aledo ISD Administration Building will still serve as a voting site for the District's May 6, 2023 bond election.
