1. Custodian Recommendation – Mark Moline

Interviews for the custodial position were conducted on Monday, October 21, 2019. The interview committee consisted of Ms. Lisa Abbey, Interim Director of Business and Operations; Mr. Scott Jacobs, Maintenance and Operations Supervisor; and Mr. Tony DeMarco, HR/Payroll Specialist. The committee is recommending Mr. Mark Moline for this position. Mark has been a substitute custodian in the district for the last few months. He has proven to be dependable and a hard worker.
