Recommend approval for an Official Notice and Order of the Brownsville Independent School District Trustee Special Election scheduled on Saturday, May 3, 2025.

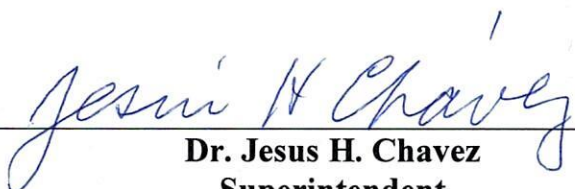
