

**RESOLUTION AUTHORIZING THE TRANSFER OF EMPLOYMENT OF CERTAIN
EMPLOYEES OF THE MID-STATE SPECIAL EDUCATION COOPERATIVE TO THE
PANA COMMUNITY UNIT SCHOOL DISTRICT NO. 8**

WHEREAS, the Board of Education of the Pana Community Unit School District No. 8 (hereinafter the “Board”) is authorized to direct and manage the ongoing operations of the Pana Community Unit School District No. 8, including the assignment and transfer of staff; and

WHEREAS, as a Member District of the Mid-State Special Education Cooperative (hereinafter “MID-STATE”), the Pana Community Unit School District No. 8 analyzed the best method of delivery of special education and related services to those eligible students of such Pana Community Unit School District No. 8; and

WHEREAS, the Pana Community Unit School District No. 8 has determined that it is in the best interest of the students served to provide the required special education and related services by its own staff, with such ancillary and support services, formerly provided by MID-STATE, be provided by the Taylorville Community Unit School District No. 3, as and for the fiscal and legal agent of the NPT Special Education Cooperative, effective July 1, 2019 as may be needed for eligible special education students; and

WHEREAS, Section 10-21.12 of *The School Code*, authorizes the transfer of teachers from one Joint Agreement to a Board of Education or another Joint Agreement when programs have been reduced in the Joint Agreement; and

WHEREAS, the decision of the Pana Community Unit School District No. 8 to employ its own special education and related services has required the reduction of programs and staff of MID-STATE; and

WHEREAS, because of the reduction of programs, it has been determined by the Pana Community Unit School District No. 8 that ten (10) MID-STATE teaching employees be

transferred to Pana Community Unit School District No. 8; such employees being identified hereinafter in this Resolution; and

WHEREAS, any MID-STATE teacher that is then employed by Pana Community Unit School District No. 8 shall be deemed “transferred” pursuant to Section 10-21.12 of *The School Code* and have all rights accorded to the transferred employee by such section of *The School Code*; and

WHEREAS, because of the reduction of programs, it has been determined by the Pana Community Unit School District No. 8 that fourteen (14) MID-STATE educational support personnel employees be transferred to Pana Community Unit School District No. 8 for positions to which they are qualified and assigned; such employees being identified hereinafter in this Resolution.

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Pana Community Unit School District No. 8:

Section 1. Because of a decision of the Pana Community Unit School District No. 8 to provide the required special education and related services by its own staff, with such ancillary and support services to be provided by the Taylorville Community Unit School District No. 3, as and for the fiscal and legal agent of the NPT Special Education Cooperative, CAYLA BEYERS, CANDY BYARS, LESLIE CLAVIN, SARAH CROSBY, DESI HENSCHEN, GRACE HOLTHAUS, ADAM METZGER, LORI SMOTHERS, JASON STORM and DIANNE WILLIAMS shall be transferred to the Pana Community Unit School District No. 8, in accordance with, and to the extent allowed by, Section 10-21.12 of *The School Code*, 105 ILCS 5/10-21.12, effective July 1, 2019.

Section 2. Because of a decision of the Pana Community Unit School District No. 8

to provide the required special education and related services by its own staff, with such ancillary and support services to be provided by the Taylorville Community Unit School District No. 3, as and for the fiscal and legal agent of the NPT Special Education Cooperative, SUSAN BARR, DEBBIE BEYERS, SHAWN COLLINS, REBECCA DAGEN, MEGAN DAUGHERTY, MARY BETH DENTON, LORI HUTCHINSON, KELLY LEDUC, BARBY RENOE, CAROL RICHTER, SCOTT SIMS, KIM SIPES, SHERRI VITS shall, effective July 1, 2019 be transferred to, and employed by the Pana Community Unit School District No. 8, in positions for which they are qualified and assigned and subject to the provisions of any applicable bargaining agreement.

Section 3. The MID-STATE Director shall provide all needed information to the Pana Community Unit School District No. 8 to effectuate such transfer of employment and to allow the transferred employees to benefit from all rights accorded to them under Section 10-21.12 of *The School Code*, 105 ILCS 5/10-21.12.
