Dr. Shiela Shiver provided an introduction to the priority report on student achievement and post secondary preparedness. Dr. Stephanie Speaks shared the CTE Cascading Scorecard priority 1 and priority 3. She shared the outcome measures for performance objective 1.2, performance objective 3.2 and performance objective 3.3. Dr. Speaks explained the CTE program. She shared CTE accountability beginning in the 2025-2026 school year due to House Bill 2 and Texas Administrative Code 74.13 requirements. She shared events that have already taken place this school year, including Fall 2025 CTE Mock Interviews, Middle School Tours, and CTE Experience. She shared that CTE teachers participated in summer externships. She shared that CTE now has a partnership with Tarleton State University that offers dual enrollment and shared instructional practices and advanced animal science and potential courses for 2026-2027. She shared industry-based certifications related to public service and STEM. She shared projections of target occupations for North Central Texas over the next five years and how they align with what CTE currently offers.

G. Course Selection Guide - Updates for 2026-2027

Dr. Shiela Shiver explained the course selection guide process, including the committee's work on recommended course additions, revisions, and deletions. She explained the communication process that began in January. She reviewed the recommended changes to the middle school course selection guide. She explained co-seating. She shared the comparison of current English Language Arts, Math, Science, and Social Studies courses side by side with courses in same content for the 2026-2027 school year. She explained the accelerated pathway. She shared other changes related to the middle school course related to core academic support and extension such as math, reading dyslexia, AVID, Gifted and Talented Independent Study, Removing the STEM label at GMS. STEM focus and opportunities will remain. All middle school students have STEM standards in their courses due to state requirements.

Questions took place.

Mandy Ozuna reviewed the legislative changes pending an update on SB1191 on the standard method of GPA. There is a new graduation requirement from HB27. She shared the key changes to expand dual credit/pathway access. She reviewed the new dual credit offerings with Tarleton State University. She shared the new dual credit fine arts option with McMurray University, policy revision for dual credit prerequisites, and explained the key mandated changes.
