On May 6, 2021 at 2:00 p.m., bids were received from four companies for the Multi-site Intercom Replacement project at Roselle Middle School and Spring Hills Elementary. A bid tabulation is attached for your records. Sound, Inc., from Naperville, Illinois, submitted the low base bid in the amount of \$117,000.00. Sound Inc. has informed us that upon review of their bid with us, it did not include the complete scope of work. They have requested the District allow them to withdraw their bid and have their bid bond returned. We believe it is in the best interest of the District to allow them to pull their bid from consideration for award.

The next low bidder is ITR Systems of Downers Grove, Illinois with a base bid amount of \$144,980.00. Upon our review of the bid with them, they have confirmed they have included the scope of work as specified.

Our recommendation is as follows:

Allow Sound Inc. to remove their bid from consideration and return their bid bond. Sound Inc. has issued a letter to request to withdraw their bid. Award the contract to ITR Systems in the Total Contract amount of \$144,980.00.
