2. Exhibit C – Bid Form for each company who responded to the Invitation for Bid (IFB) listed above.

If there are any fees for searching or copying these records, please inform me if the cost will exceed \$1.00. However, I would also like to request a waiver of all fees in that the disclosure of the requested information is in the public interest and will contribute significantly to the public's understanding of the current transportation cost for your district.

I would request a response in writing, within the five (5) days described by law, if you intend to deny this request. Also, if you expect a significant delay in fulfilling this request, please contact me with information about when I might expect copies or the ability to inspect the requested records.

If you deny any or all of this request, please cite each specific exemption you feel justifies the refusal to release the information and notify me of the appeal procedures available to me under the law.
