A Workshop Meeting of the Board of Trustees of Kaufman ISD was held on Monday, July 21, 2025, beginning at 5:00 PM in the Kathy Covington Administration Building, 1000 South Houston Street, Kaufman, Texas 75142.

CALL TO ORDER: Establish a quorum
