BACKGROUND:

Administration is requesting approval of Resolution No. 008/25-26 to participate in the purchasing programs of Region One Education Service Center Child Nutrition Program-South Texas Cooperative (CNP-STC) for fiscal year 2025-2026. Participation in this purchasing program facilitates the benefit of volume purchasing that result in anticipated savings to the district. No fees are assessed by the cooperative. The FNS Department is a member of the CNP-STC as granted by Article 791 et. Seq. of the Interlocal Cooperative Act in 1999. This resolution allows the FNS Department to purchase all categories of goods and services including commodity processing services and other awarded contracts necessary for the operation of the FNS Department.




