## **Resolution** to Direct the Reduction of 2024 Levy

**WHEREAS**, the Board of Education (the "Board') of River Trails School District #26, Cook County, Illinois (the "District"), by resolution adopted the 2024 Levy on December 10, 2024; and

**WHEREAS**, the adopted levy may exceed the amount permitted by the Property Tax Extension Limitation Act (PTELA), PA 89-01 (the "Law") as determined by the Cook County Clerk; and

**WHEREAS**, the law requires the Board to notify the Cook County Clerk what funds should not be limited listing the maximum amount to be raised in each fund; and

**WHEREAS**, the law requires the Board to notify the Cook County Clerk what fund the Board wants limited, stating the minimum amount to be maintained in that fund; and

**NOW, THEREFORE, Be It And It Is Hereby Resolved** by the Board of Education of River Trails School District #26, Cook County, Illinois, as follows:

Section I. That the Board of Education hereby finds that all of the recitals contained in the preambles to this resolution are full, true and correct and does hereby incorporate them into this Resolution by reference.

Section II. That if the County Clerk is required to reduce the aggregate extension of the School District to meet the requirements of the PTELL, the Board of Education hereby authorizes and directs the County Clerk that if any reductions are required to be made to the School District's tax levy for the 2024 levy year, that:

100% of such reductions shall be made from the Education Fund.

Section III. The Secretary of the Board is to file a certified copy hereof with the Cook County Clerk, State of Illinois.

*Section IV.* The Board affirms it shall be the duty of the said Cook County Clerk to decrease the said levy for the year 2024 in accordance with the provisions hereof.

*Section V.* This resolution shall be in full force and effect forthwith upon its adoption this 10th day of December 2024.
