## PLEDGE OF ALLEGIANCE

Board Chairman Brad McRoberts called for the Pledge of Allegiance to the Flag of the United States of America.

## **ROLL CALL**

Roll was called, the following Commissioners were present: Bradley McRoberts, Robert Adrian, Dave Karschnick, Bill Peterson, Brenda Fournier, Ronald McDonald, Kevin Burr and John Kozlowski.

# **PUBLIC COMMENT**

Sheriff Kieliszewski gave an update on the new Jail project and the ground-breaking ceremony that took place today. He reported the base security contract bid process was unsuccessful and will be extended for an additional two months. Steve also mentioned that Terry King's name was omitted from the groundbreaking ceremony program for the new jail facility and he wanted to give him a thanks for his help.

#### THE HONORABLE BOARD OF COMMISSIONERS:

RESOLUTION IMPOSING 2019 SUMMER PROPERTY TAX LEVY PURSUANT TO PUBLIC ACT 357 OF 2004 AND NOTICE OF CERTIFICATION OF COUNTY ALLOCATED TAX LEVY.

WHEREAS, Alpena County is authorized under the General Property Tax Act, Public Act 206 of 1893, as amended to levy and collect County allocated property taxes; and

WHEREAS, the General Property Tax Act has been amended by Public Act 357 of 2004, being MCL 211.44a, to require all Michigan Counties to impose a summer tax levy.

BE IT FURTHER RESOLVED, that pursuant to Public Act 357 of 2004, the Alpena County allocated tax shall be levied and collected on July 1, 2019 at a rate, allocated after application of the "Headlee" millage reduction fraction, of 4.8004 mills.

BE IT FURTHER RESOLVED, that the Treasurer of each City and Township in Alpena County is directed to account for and deliver the County allocated tax collections for 2019 in accordance with the provisions of Public Act 357 of 2004; and

BE IT FURTHER RESOLVED, that this Resolution constitutes certification of the levy of County allocated tax on July 1, 2019 at a rate, allocated after application of the "Headlee" millage reduction fraction, of 4.8004 mills.

NOW, THEREFORE, BE IT RESOLVED that the total 2019 millage rate for July 1st, 2019 for Alpena County of 4.8004 mills is hereby adopted; and

BE IT FURTHER RESOLVED, that the 2019 Alpena County July levies shall be as follows:

BE IT FURTHER RESOLVED, that the County Clerk shall deliver a copy of this resolution by first-class mail to the Treasurer of each City and Township in Alpena County, and

BE IT FURTHER RESOLVED, that the Chairperson of the Board of Commissioners and the County Clerk be authorized to sign the form L-4029 2019 Tax Rate Request with the above mentioned millages, and

WHEREAS, The County Revenue will be reduced due to the State distribution to Alpena County of the Convention Facility and Health and Safety Facility payment, and

NOW THEREFORE BE IT HEREBY RESOLVED, that this Resolution be adopted by the Alpena County Board of Commissioners, at the regular meeting on May 21, 2019.
